RESOLUTION NO. 2020-08

A RESOLUTION REQUESTING THE LAKE COUNTY AUDITOR TO MAKE ADVANCE PAYMENTS OF TAXES IN 2021 AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Revised Code allows a taxing authority to request payment from the County Auditor fund derived from taxes or other sources to the County Treasurer, which may be held on account of a local subdivision.

NOW, THEREFORE, BE IT RESOLVED THAT THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO, THAT:


SECTION 1. That the Auditor and the Treasurer of Lake County in accordance with Ohio Revised Code Section 321.34, be requested to draw and pay to the City of Willoughby Hills upon written request of Frank J. Brichacek, Jr., Director of Finance and/or Jeffrey Stergar, Assistant Director of Finance and/or G. Andrew Gardner, Mayor to the Lake County Auditor, funds due in any settlement of 2021 derived from taxes or other sources, payable to the County Treasurer to the account of the City of Willoughby Hills, and lawfully applicable for purposes of the current fiscal year beginning January 1, 2021 and ending December 31, 2021. Finance Director Brichacek has provided an interoffice memo dated October 1, 2020 (**EXHIBIT 1**) documenting this request.

SECTION 2. The actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This resolution constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual daily operation of the municipality and further reason the timely availability of revenue to finance the day-to-day operations of the City; wherefore this resolution shall be in full force and effect from and after its adoption and approval by the Mayor.


SECTION 4. That the Clerk of Council of the City of Willoughby Hills shall forward to the Lake County Auditor a certified copy of this Resolution.
