ORDINANCE NO. 2020-12 – THIRD READING

AN ORDINANCE AMENDING THE CONTRACT BETWEEN BROWNING-FERRIS INDUSTRIES OF OHIO, INC. (BFI) AND THE CITY OF WILLOUGHBY HILLS FOR CITYWIDE TRASH & RECYCLING PROGRAM TO INCLUDE YARD WASTE PICKUP, REPEALING CONFLICTING LEGISLATION AND DECLARING AN EMERGENCY.
