### AN ORDINANCE ACCEPTING THE BID OF OSBORNE CONCRETE & STONE FOR THE PURCHASE OF ASPHALT FOR THE YEAR 2016 AND DECLARING AN EMERGENCY.

WHEREAS, the Council of The City of Willoughby Hills on January 14, 2016, by motion, granted the Mayor authorization to advertise for bids to secure the City's requirement of asphalt for the year 2016; and

WHEREAS, the Council of the City of Willoughby Hills has reviewed and accepts the recommendations as provided by the Mayor in his Memorandum, dated February 15, 2016 directed to the Members of Council and Council Clerk, attached hereto as the "Exhibit A", consisting of five (5) pages and incorporated herein by reference, finding the following bid of: \$57.00 per ton/picked up for Type 1 Asphalt; \$48.25 per ton/picked up for Type 2 Asphalt; \$46.75 per ton/picked up for #301 Asphalt as submitted by Osborne Concrete & Stone to be the lowest and best bid in conformance with all contract requirements.

**SECTION 3.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.
