ORDINANCE NO. 2016-3 –AMENDED

AN ORDINANCE ADOPTING PERMANENT APPROPRIATIONS NECESSARY TO MAINTAIN CITY SERVICES FOR THE FISCAL PERIOD BEGINNING JANUARY 1ST THROUGH DECEMBER 31ST OF 2016; REPEALING CONFLICTING LEGISLATION.

WHEREAS, the Council of the City of Willoughby Hills on December 10, 2015 adopted Ordinance No. 2015-44 making available interim appropriations for expenses and other expenditures within the City of Willoughby Hills for the fiscal period beginning January 1, 2016 through March 31, 2016; and

WHEREAS, on February 5, 2016 the Finance Director prepared and submitted to Council the initial "Schedule of 2016 Appropriations"; and

WHEREAS, on February 25, 2016 the Finance Director submitted to Council revisions to the 2016 Operating Budget: "2016 Operating Budget Revisions – As of February 25, 2016" and "2016 Operating Budget Revisions – As of February 17, 2016" marked as the "Exhibit B" attached hereto, consisting of three (3) pages and incorporated herein by reference; and

WHEREAS, Council accepts the revisions to the 2016 Operating Budget as submitted by the Finance Director and is in concurrence with the recommendation of the Finance Committee to adopt this Ordinance to provide funds for the current expenses and any other expenditures of the City of Willoughby Hills for the fiscal period of January 1st through December 31st of 2016; and

WHEREAS, pursuant to Section 6.2 – Effective Date of Ordinances of the Charter of the City of Willoughby Hills said Ordinance shall take effect upon its signature by the Mayor.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. To provide funds for the current expenses and other expenditures of said City of Willoughby Hills during the period beginning January 1, 2016 through December 31, 2016, the sums as provided in the Schedule of 2016 Appropriations, prepared 02/05/16; revised 2/25/16 marked as the "Exhibit A - Revised 2/25/16", attached hereto, consisting of five (5) pages and incorporated herein by reference, be and hereby are set aside and appropriated hereafter.

SECTION 2. All monies in the Trust & Agency Funds Accounts are hereby deemed appropriated for their intended purposes.

SECTION 3. All expenditures within the fiscal year ending December 31, 2016 shall be made in accordance with the code accounts hereinabove set forth and shall be made within the appropriations herein "Appropriation" as used means the total amount appropriated for the individual fund. provided. Notwithstanding the financial detail herein presented, the Mayor or the Finance Director is authorized to transfer budgeted amounts within each fund provided that the total amount appropriated for the fund is not exceeded.

SECTION 4. The City Finance Director be and is hereby authorized and directed to draw his warrants against the appropriations set forth upon presentation of proper vouchers.
