ORDINANCE NO. 2016-10

AN ORDINANCE DIRECTING THE MAYOR TO SIGN ANY AND ALL NECESSARY DOCUMENTS TO SECURE THE PURCHASE OF POLICE VEHICLES FOR BUDGET YEAR 2016 THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING AGREEMENT CONTRACT WITH SAID PURCHASE BEING EXEMPT FROM COMPETITIVE BIDDING PURSUANT TO SECTION 125.04 (C) OF THE OHIO REVISED CODE AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to the Police Department Memorandum from Police Chief Christopher J. Collins to Mayor/Safety Director Robert M. Weger, dated March 2, 2015 Police Chief Collins has respectfully requested approval for the purchase of two (2) new police vehicles for Budget Year 2016 through the State of Ohio Cooperative Purchasing Agreement Contract No. RS901214, effective 10/16/2015 to 09/30/2016, renewed through 09/30/2015; and

WHEREAS, in accordance with State Contract Law Enforcement Vehicle Specifications and pricing with available options, two 2016 Police Package Dodge Chargers are to be purchased from Greve Chrysler, Dodge Jeep, 756 West Ervin Street, Van Wert, Ohio 45891, cost with options and delivery would be **\$24,257.50** each, for a total vehicle purchase price of **\$48,514.00**; these cars would be assigned to the Patrol Division; and

WHEREAS, said vehicle costs do not include the cost of police emergency equipment, equipment changeovers, installation, painting and police decaling estimated as follows: (a) painting doors white \$200 @ = \$400; (b) decals \$450.00 @ \$900.00; (c) Coban In-Car Video System - \$5,100.00 @ = \$10,200.00; purchase and installation of new and old equipment - \$7,000 @ = \$14,000.00; and

WHEREAS, the total estimated cost to purchase and equip these cars is \$74,014.00; and

WHEREAS, the funding source will be Capital New Vehicles #234.230.56600.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor is hereby authorized and directed to sign any and all necessary documents to secure the purchase of: two 2016 Police Package Dodge Chargers from Greve Chrysler, Dodge Jeep, 756 West Ervin Street, Van Wert, Ohio 45891, cost with options and delivery would be **\$24,257.50** each, for a total vehicle purchase price of **\$48,514.00**. Said purchase costs do not include equipment changeover, installation and decaling.

SECTION 2. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the Police Department, and further reason to wit: to immediately purchase two 2016 Police Package Dodge Chargers and thereby adhere to a regular purchasing schedule; wherefore, this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
