ORDINANCE NO. 2016-12

AN ORDINANCE DIRECTING THE MAYOR TO SIGN ANY AND ALL NECESSARY DOCUMENTS TO SECURE THE PURCHASE OF A 2016 GMC 3500HD PICKUP THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING AGREEMENT CONTRACT WITH SAID PURCHASE BEING EXEMPT FROM COMPETITIVE BIDDING PURSUANT TO SECTION 125.04 (C) OF THE OHIO REVISED CODE AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to the Interoffice Memo from Mayor Robert M. Weger to Council President, Council Clerk and Council Members, dated March 30, 2016 the Mayor respectfully requested approval for the purchase of a 2016 GMC 3500HD Pickup through the State of Ohio Cooperative Purchasing Agreement Contract No. RS901216, Index #GDC093, Item #29AT effective November 13, 2015 to October 31, 2016; and

WHEREAS, in accordance with the terms of the State of Ohio Cooperative Purchasing Agreement Contract the abovementioned vehicle will be purchased from Bob Ross Buick, Inc., 85 Loop Road, Centerville, Ohio, 45459, at total vehicle purchase price of **\$37,084.00**; and

WHEREAS, pursuant to the Interoffice Memo from Road Superintendent Mark Grubiss to Mayor Robert Weger, dated March 30, 2016, the cost of the abovementioned vehicle will exceed the budgeted amount of \$30,000; and

WHEREAS, the Road Superintendent proposed that the additional funding of \$7,084 be obtained from the Capital Improvement Fund #420.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor is hereby authorized and directed to sign any and all necessary documents to secure the purchase of a 2016 GMC 3500HD Pickup with said purchase to be made through the State of Ohio Cooperative Purchasing Agreement Contract No. RS901216, Index #GDC093, Item #29AT effective November 13, 2015 to October 31, 2016.

SECTION 2. In accordance with the terms of the State of Ohio Cooperative Purchasing Agreement Contract the abovementioned vehicle will be purchased from Bob Ross Buick, Inc., 85 Loop Road, Centerville, Ohio, 45459, at total vehicle purchase price of **\$37,084.00**; see the Sales Quotation dated February 4, 2016 consisting of one page, attached hereto as the **“Exhibit A”**.

SECTION 3. Funding for said purchase shall be provided as follows: \$15,000 from the Street Construction, Maintenance & Repair Fund #250; \$15,000 from the Sewer Enterprise Fund #610 and \$7,084 from the Capital Improvement Fund #420.

SECTION 4. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 5. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the Service Department, and further reason to wit: to immediately purchase a 2016 GMC 3500HD Pickup to better serve the residents of the City; wherefore, this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
