## **ORDINANCE NO. 2016-22**

AN ORDINANCE AMENDING PART NINE - STREETS, UTILITIES & PUBLIC SERVICES, TITLE FIVE - OTHER PUBLIC SERVICES, CHAPTER 941 - USE OF PUBLIC PROPERTY, SECTION 941.05 - CAMPBELL PARK AND CAMPBELL PARK FIELD, SUB-SECTION (c); SECTION 941.07 - WILLOUGHBY HILLS COMMUNITY CENTER, SUB-SECTIONS (g) AND (h) OF THE CODIFIED ORDINANCES OF THE CITY OF WILLOUGHBY HILLS AND REPEALING CONFLICTING LEGISLATION.

WHEREAS, the City owns various properties and facilities that are available for rent by the general public; and

WHEREAS, pursuant to the Mayor's Interoffice Memo to Council President, Council Clerk, and Council Members, dated May 5, 2016 the Mayor respectfully requested legislation to amend the Community Center and Campbell Park by increasing the rates as presented in the "Exhibit A", consisting of two (2) pages and included herein by reference.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. Section 941.05 - Campbell Park, specifically Sub-Section (c) of the Codified Ordinances of the City of Willoughby Hills be, and it hereby is amended to read and provide, in its entirety, as follows:

## CAMPBELL PARK AND CAMPBELL PARK FIELD. **"941.05**

The schedule of charges for Campbell Park shall be established by the Council of the City of Willoughby Hills and is as follows:

Rates are for rentals for private events. Private events are events not open to the general public, i.e. family parties, birthdays, receptions, showers, etc.

To qualify for the Resident rate, contract holder must be a Willoughby Hills resident, provide proof of residency and must be present at the event. Payment and all event details must be facilitated through contract holder only."

The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 6.** This Ordinance shall be in full force and take effect at the earliest time permitted by law.
