ORDINANCE NO. 2016-40

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO STATE OF OHIO ADMINISTRATIVE SERVICES CONTRACT(S) FOR THE PURCHASE OF A ONE TON CAB AND CHASSIS FOR USE BY THE SERVICE DEPARTMENT AND DECLARING AN EMERGENCY.

WHEREAS, Ohio Revised Code Section 5513.01(B) provides the opportunity for counties, townships and municipal corporations to participate in contracts of Ohio Department of Administrative Services for the purchase of machinery, materials, supplies or other articles; and

WHEREAS, this Council wishes to take advantage said opportunity by acquiring a 2016 GMC 3500 SIERRA 12,800lb. DRW 4WD Regular Cab Flex Fuel (State of Ohio Contract #RS901216, Index #GDC093, Item #33AT) as provided by vendor Ross Auto Group, 85 Loop Road, Centerville, Ohio 45459.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor accordingly be and is hereby authorized and directed to request authority in the name of the City of Willoughby Hills to participate in Ohio Department of Administrative Services Contract(s) for the purchase of a 2016 one-ton cab and chassis (State of Ohio Contract #RS901216, Index #GDC093, Item #33AT), with said vehicle being provided by vendor Ross Auto Group, Government Sales Department at a cost of \$37,132.00, identified in the quote dated February 26, 2016 attached hereto as the "Exhibit A", consisting of one (1) page and incorporated herein by reference.

SECTION 2. The City of Willoughby Hills hereby agrees to be bound by the terms and conditions prescribed by the Director of Administrative Services for the abovementioned purchase and to directly pay the vendor, under each such contract of the Ohio Department of Administrative Services in which the City participates for items and/or services it receives pursuant to the contract.

<u>SECTION 3</u>. The Mayor be and is hereby authorized to enter into and execute such Agreements and Documents as may be necessary to participate in the Ohio Department of Administrative Services Cooperative Purchasing Program.

SECTION 4. Finance Director Brichacek confirmed that the 2016 Operating Budget provides \$65,000 for the purchase and outfitting of a one-ton cab and chassis by utilizing funds from the Street Construction, Maintenance and Repair Fund #250 with any shortfall most likely to come from savings in salt.

SECTION 5. The actions of this Council concerning and relating to the passage of this legislation were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 6. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the Service Department and further reason being that the City wants to put the one-ton dump truck into service by winter; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
