ORDINANCE NO. 2016-46 - AMENDED

AN ORDINANCE ACCEPTING THE MUTUAL AGREEMENT FOR TECHNICAL ASSISTANCE BETWEEN THE CITY OF WILLOUGHBY HILLS AND LAKE COUNTY [OHIO] SOIL & WATER CONSERVATION DISTRICT.

WHEREAS, the City of Willoughby Hills has utilized the Soil & Water Conservation District services and support through formal agreements and voluntary appropriations since 1994; and

WHEREAS, the Council of the City of Willoughby Hills recognizes the necessity to comply with the OEPA's Phase II Storm Water Permit requirements with its accompanying need for District services and technical support not offered in the original mutual agreement which was executed in 1994; and

WHEREAS, on February 26, 2004 the City Council of Willoughby Hills adopted <u>Ordinance No. 2004-</u> <u>7</u> enlisting the services and technical support of the Lake County (Ohio) Soil & Water Conservation District to aid in the administration of the City's Erosion and Sediment Control <u>Ordinance No. 2004-4</u>, previously adopted by Council on January 22, 2004; and

WHEREAS, the City Council of Willoughby Hills recognizes the need for effective relationships in carrying out their mandated responsibilities, and accepts this new mutual agreement, as updated by the Lake County Soil and Water Conservation District, as the current document which describes the process of exchange of cooperation as set forth by the Ohio Revised Code, Chapters 939 and 940.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

<u>SECTION 1.</u> The Mayor is hereby authorized and directed to enter into a new mutual agreement, presented by the Lake County Soil and Water Conservation District for the continuation of services and technical assistance with the Lake County [Ohio] Soil and Water Conservation District, substantially pursuant to the terms and conditions as identified in the *Mutual Agreement for Technical Assistance Between the City of Willoughby Hills and Lake County [Ohio] Soil & Water Conservation District*, attached hereto as the "Exhibit A", consisting of four (4) pages and incorporated herein by reference.

<u>SECTION 2</u>. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This Ordinance be in full force and effect at the earliest time permitted by law.
