## ORDINANCE NO. 2016-50

### AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO A CONTRACT FOR GENERAL LIABILITY INSURANCE COVERAGE FOR THE CITY OF WILLOUGHBY HILLS AND DECLARING AN EMERGENCY.

**WHEREAS**, on October 8, 2015, Council adopted Ordinance No. 2015-39 authorizing and directing the Mayor to enter into a contract for general liability insurance coverage for the City; and

**WHEREAS**, said policy had a three-year rate guarantee with an annual premium of \$72,151; and

**WHEREAS**, the inclusion of multiple traffic control boxes throughout the City resulted in a \$302.00 increase in this contract's premium; and

**WHEREAS**, the renewal rate for coverage from October 1, 2016 through October 17, 2017 is \$72,453.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:**

**SECTION 1.** The Mayor shall be, and is hereby authorized and directed to enter into a contract for General Liability Insurance Coverage at a premium or premiums not to exceed **Seventy-Two Thousand, Four Hundred Fifty-Three Dollars (\$72,453)** pursuant to the terms and conditions as identified in the ***USI – PEP Insurance Proposal Prepared for the City of Willoughby Hills, Ohio; Policy Period of October 1, 2016 to October 1, 2017; Presented by Rob Beglin, Vice President; Date Prepared October 19, 2016***, consisting of seventeen (17) pages attached hereto as the "Exhibit A", and incorporated herein by reference.

**SECTION 2.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 3.** This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it further provides for the usual daily operation of a Municipal Department, to wit: timely continuance of General Liability Insurance Coverage for the City; wherefore, this Ordinance shall be in full force and effect upon and after its passage and approval by the Mayor.
