## ORDINANCE NO. 2017-5

---

**AN ORDINANCE DIRECTING THE MAYOR TO SIGN ANY AND ALL NECESSARY DOCUMENTS TO SECURE THE PURCHASE OF POLICE VEHICLES FOR BUDGET YEAR 2017 THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING AGREEMENT CONTRACT WITH SAID PURCHASE BEING EXEMPT FROM COMPETITIVE BIDDING PURSUANT TO SECTION 125.04 (B) OF THE OHIO REVISED CODE; APPROVAL OF FUNDING IN THE AMOUNT OF \$27,018 TO PROPERLY EQUIP SAID VEHICLES; AND DECLARING AN EMERGENCY.**

**WHEREAS**, pursuant to the Police Department Memorandum from Police Chief Christopher J. Collins to Mayor/Safety Director Robert M. Weger, dated January 4, 2017 Police Chief Collins has respectfully requested approval for the purchase of two (2) 2017 Police Package Dodge Chargers through the State of Ohio Cooperative Purchasing Agreement Contract No. RS9000917, effective 10/14/2016 to 09/30/2017; and

**WHEREAS**, in accordance with State Contract Law Enforcement Vehicle Specifications and pricing, two 2017 Police Package Dodge Chargers are to be purchased from Greve Chrysler, Dodge Jeep, 756 West Ervin Street, Van Wert, Ohio 45891, at a cost of **\$23,559.50** each, for a total vehicle purchase price of **\$47,118.00**; these cars would be assigned to the Patrol Division; and

**WHEREAS**, purchase price of the abovementioned vehicles does not include equipment changeover, the installation and decaling which would be at a cost of \$27,018; and

**WHEREAS**, the total cost to purchase and equip the two vehicles would be \$74,136.00; the approved funding source shall be the Capital New Vehicles #234.230.56600.

***NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:***

**SECTION 1.** The Mayor is hereby authorized and directed to sign any and all necessary documents to secure the purchase of: two 2017 Police Package Dodge Chargers from Greve Chrysler, Dodge Jeep, 756 West Ervin Street, Van Wert, Ohio 45891, at a total cost of **\$23,559.50** each, for a total purchase price of **\$47,118.00**.


**SECTION 2.** As the total purchase price of \$47,118.00 for two 2017 Police Package Dodge Chargers does not include equipment changeover, the installation and decaling, Council hereby approves the following expenditures in the amount of **\$27,018.00**: 1 COBAN In-Car Video System at \$5,550.00; paint doors white @ \$900.00; police decals @ \$900.00; and the purchase and installation of new/old emergency equipment and radios @ \$19,718.00.


**SECTION 3.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 4.** This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the Police Department, and further reason to wit: to immediately purchase two 2017 Police Package Dodge Chargers and thereby adhere to a regular purchasing schedule; wherefore, this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.


