ORDINANCE NO. 2017-74

AN ORDINANCE ENGAGING THE LEGAL SERVICES OF TODD D. CIPOLLO CO., L.P.A. TO PERFORM PROSECUTION WORK IN THE MAYOR'S COURT OF THE CITY OF WILLOUGHBY HILLS; REPEALING CONFLICTING LEGISLATION AND DECLARING AN EMERGENCY.

WHEREAS, on October 12, 2017, Council enacted Ordinance No. 2017-70 engaging Stephen L. Byron and the Law Firm of Walter | Haverfield, LLP as Acting Law Director for the City of Willoughby Hills, to perform the duties, and exercise the authority of, the City's Law Director as the "Acting Law Director"; and

WHEREAS, the Mayor has requested Todd D. Cipollo to perform the services of the prosecutor for the Mayor's Court of the City of Willoughby Hills; and

WHEREAS, Stephen L. Byron, serving as the Acting Law Director of Willoughby Hills, is recommending Todd D. Cipollo, of Todd D. Cipollo, Co., L.P.A. be formally authorized to continue to perform prosecution work in the Mayor's Court of the City of Willoughby Hills, and compensated for such services; and

WHEREAS, pursuant to Article III, Section 3.3 of the Willoughby Hills Charter this Council is authorized and directed to fix the salary or compensation of every officer and employee of the Municipality.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. Todd D. Cipollo, of Todd D. Cipollo, Co., L.P.A., when performing prosecution services for the City of Willoughby Hills, shall be paid compensated at a rate of ninety-five and no/100 dollars (\$95.00) per hour, payable monthly upon the submittal of a detailed billing statement.

SECTION 2. At the conclusion of the tax year provided for herein, the City shall issue Todd D. Cipollo Co., L.P.A. located at The Rockefeller Building, Suite 1300, 614 West Superior Avenue, Cleveland, Ohio, 44113, the form known as a "1099," or equivalent reporting form as provided for by law.

SECTION 3. All ordinances or parts thereof inconsistent with the terms and provisions of this ordinance be, and the same hereby are, repealed.

SECTION 4. All the actions of this Council concerning and relating to the passage of this legislation were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.
