## ORDINANCE NO. 2017-78

### AN ORDINANCE AUTHORIZING THE EXPENDITURE OF \$27,948.33 REQUIRED FOR THE ANNUAL SUPPORT/SERVICE CONTRACT FOR THE CODY CAD/RMS SYSTEM.

**WHEREAS, Section 115.02 – Expenditures for all Departments** of the Codified Ordinances of the City of Willoughby Hills provides that the Mayor is authorized to make purchases for any Department of the City for materials, supplies, equipment, labor, professional services or related items up to the amount of two thousand dollars (\$2,000) per purchase, provided that sufficient sums within such Department(s) for such expenditures have been appropriated; and

**WHEREAS,** this Council is in receipt of the Mayor’s Interoffice Memo dated November 6, 2017, which included a Police Department Memorandum from Chief Christopher J. Collins to the Mayor, dated November 6, 2017, requesting an ordinance authorizing the expenditure for the CODY systems annual service contract for the period of February 1, 2018, through January 31, 2019; and

**WHEREAS,** this Council desires to authorize the expenditure of \$27,948.33 to pay for the cost of the annual support/service contract for the City’s CODY CAD/RMS System.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:**

**SECTION 1.** Council hereby authorizes the expenditure of funds in the amount of \$27,948.33 from the Safety Forces Fund #234 required for the cost of the annual support/service contract for the City’s CODY CAD/RMS System.

**SECTION 2.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its Committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 3.** This Ordinance shall be in full force and take effect at the earliest time permitted by law.
