PROJECT DESCRIPTION

The project consists of Mr. Pietro DiFranco acting as Zoning Administrator for the City between July 1, 2018 and December 31, 2018 (26 weeks), with the assistance of Bowen staff as needed. Mr. DiFranco has been performing these duties since the former full-time Zoning Administrator retired on April 13, 2017, with the initial 10 weeks following the retirement performed as a courtesy, at no cost to the city.

These services will be provided on an as-needed, part-time basis, assuming not more than fourteen (14) hours per week will be demanded. Based on the part-time basis, the duties of Zoning Administrator will be prioritized based on available time. The review & issuance of zoning certificates and permits, and coordination with PCABR and BZA, will have a high priority; while addressing general zoning inquires, complaints, and opinions will have secondary priority.

SCOPE OF SERVICES

The Zoning Administrator shall have the powers and duties as listed in Section 1109.02 of the Willoughby Hills Codified Ordinances (Ord. 2006-35).
