## ORDINANCE NO. 2018-45 - AMENDED

---

### **AN ORDINANCE FIXING THE COMPENSATION FOR THE POSITION OF PART-TIME RECREATION COORDINATOR; REPEALING CONFLICTING LEGISLATION AND DECLARING AN EMERGENCY.**

---

**WHEREAS**, Section 3.32 of the Charter of the City of Willoughby Hills requires that the Council fix by ordinance the compensation of every officer and employee of the Municipality.

**NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:**

#### **SECTION 1. COMPENSATION.**

In accordance with Section 3.32 of the City Charter, Council has fixed the compensation for the position of **Part-Time Recreation Coordinator** as follows:

##### **Section 1.1 Hourly Rate.**

**Part-Time Recreation Coordinator                      \$ 13.25**

The 2018 Operating Budget specifically provides for the compensation of the position of the Part-Time Recreation Coordinator: 50% from the General Fund #110 and 50% through the Recreation Operation Fund #280.

#### **SECTION 2. STAFFING LEVEL.**

**Section 2.1** The required staffing level for said positions shall be **(1) Part-Time Recreation Coordinator.**

**SECTION 3.** All Ordinances, or parts thereof in conflict with the provisions of this Ordinance be, and are hereby repealed as of the effective date of this Ordinance; specifically, Ordinance No. 2014-74 and Section 2, Section 5 and Section 6 of Ordinance No. 2011-6.


**SECTION 4.** All the actions of this Council concerning and relating to the passage of this legislation were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.


**SECTION 5.** This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of a municipal department, and further provides for the fixed compensation for the position of Part-Time Recreation Coordinator and to be granted commencing with the first pay following the passage of said ordinance; wherefore, this Ordinance shall be in full force and take effect from and after its adoption and approval by the Mayor.


