

# City of Willoughby Hills

## ORDINANCE NO. 2019-39

---

### **AN ORDINANCE AUTHORIZING THE EXPENDITURE OF FUNDS ASSOCIATED WITH THE CONSTRUCTION AND ENGINEERING OF A PORTION OF WHITE ROAD INCLUDED IN MAYFIELD VILLAGE 2019 ROAD MAINTENANCE PROGRAM AND DECLARING AN EMERGENCY.**

**WHEREAS**, Mayfield Village previously approached the City with respect to partnering with them in repaving a portion of White Road located by Marcum Boulevard given that the City bears half of the responsibility; and

**WHEREAS**, the City Engineer had estimated that the City's cost of the project would be roughly between \$35,000 to \$50,000; and

**WHEREAS**, on March 28, 2019, Council adopted Ordinance No. 2019-19 (as amended) providing permanent appropriations necessary to maintain city services for the fiscal period beginning January 1<sup>st</sup> through December 31<sup>st</sup> of 2019; and

**WHEREAS**, with the 2019 annual budget, Council had approved \$50,000 for the resurfacing of White Road; and

**WHEREAS**, Council is in receipt of the Mayor's Interoffice Memo dated May 2, 2019, consisting of eighteen(18) pages, attached hereto as the "Exhibit A", within said Memo the Mayor requested an ordinance be prepared accepting the quote presented by Mayfield Village for the construction and engineering of a portion of White Road as included within the Mayfield Village 2019 Road Maintenance Program; and

**WHEREAS**, the Mayor stated that the work would be done by Chagrin Valley Paving following the appropriate bid process conducted by Mayfield Village; and

**WHEREAS**, the Mayor also requested the allocation of \$35,000 to allow for pavement base repairs and in order to expediate the project, recommended Council take immediate action as Mayfield Village will be awarding the contract to Chagrin Valley Paving on May 6<sup>th</sup> with construction to begin or about May 13<sup>th</sup>, weather permitting.

***NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:***

**SECTION 1.** As requested by the Mayor, Council hereby grants authorization to accept the quote as presented by Mayfield Village, contained within the "Exhibit A".

**SECTION 2.** The 2019 Operating Budget (page E-64) provides for the Capital Improvement expense of \$50,000 for the White Road Resurfacing Project by utilizing funds from account #270.351.56800 – Construction. The Finance Director is hereby authorized to provide a city-issued purchase order for said expenditure of thirty-five thousand dollars (\$35,000).

**SECTION 3.** The actions of this Council concerning and relating to the passage of legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.


**SECTION 4.** This ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the municipality and further reason being that the City requires the professional services to immediately proceed with the with the construction and engineering of a portion of White Road included in the Mayfield Village ~~2019~~ 2019 Road Maintenance which is critical to maintain the integrity of the road; wherefore this ordinance shall be in full force and take effect from and after its adoption and approval by the Mayor.
