RE: Recommended Ordinance Update – 157.18 UNIFORM ALLOWANCE SAFETY FORCES

1. I would like to recommend the following section be updated to remove the Lieutenant and add the Community Service Officer as listed below. Thank you.

**157.18 UNIFORM ALLOWANCE FOR SAFETY FORCES.**

(a) The Chief of Police and Lieutenant (**REMOVE LIEUTENANT / ADD COMMUNITY SERVICE OFFICER**) shall receive a uniform allowance in the same amount as provided to the Patrol Officers and Sergeants as contained in their union agreement. (Ord. 2002-02. Passed 1-24-02.)

(b) The Fire Chief and the full-time Assistant Fire Chief of the Fire Department shall receive a uniform allowance in the same amount as Firefighters receive through their union agreement.

(c) The full-time Secretary of the Police shall receive a uniform allowance in the same amount as members of the Police Dispatchers as contained in their union agreement. Beginning in the calendar year immediately following the initial payment for uniform allowance the Secretary of Chief of Police shall receive an annual uniform allowance in accordance with the preceding schedule, such allowance to be paid in two equal payments, one/half the pay containing May 1st, and one/half the pay containing September 1st.

(Ord. 2002-115. Passed 12-12-02.)

Beginning in calendar year immediately following the initial payment for uniform allowance, each Secretary of Chief of Police and Chief of Fire shall receive an annual uniform allowance in accordance with the preceding schedule, such allowance to be paid in two equal payments, one/half of the pay period containing May 1st, and one/half of the pay period containing September 1st.
