ORDINANCE NO. 2015-41 – EXHIBIT-A

A COOPERATIVE AGREEMENT BETWEEN THE CITY OF WILLOUGHBY HILLS AND THE CITY OF KIRTLAND TO SUBMIT AN APPLICATION TO THE OHIO PUBLIC WORKS COMMISSION FOR THE WORRELL ROAD RESURFACING PROJECT.

This Cooperative Agreement is entered into this _____ day of _____, 2015, between the City of Willoughby Hills and the City of Kirtland, municipal corporations organized and existing under the laws of the State of Ohio.

NOW, THEREFORE, IT IS HEREBY AGREED BY AND BETWEEN THE CITY OF WILLOUGHBY HILLS AND THE CITY OF KIRTLAND AS FOLLOWS:

SECTION 1. The City of Kirtland authorizes the City of Willoughby Hills to serve as lead applicant and to sign all necessary documents.

SECTION 2. The City of Willoughby Hills will provide funds equal to 25 percent (25%) of the total project cost with such funds coming from the _____ **Fund.**

SECTION 3. The City of Kirtland will provide funds equal to 25 percent (25%) of the total project cost with such funds coming from the _____ **Fund.**

SECTION 4. The City of Willoughby Hills agrees to pay its 25 percent (25%) of the cost as invoices are due.

SECTION 5. The City of Kirtland agrees to pay its 25 percent (25%) of the cost as invoices are due.

SECTION 6. The Mayors of the Cities of Willoughby Hills and the City of Kirtland are hereby authorized and directed to sign any and all documents to further effectuate the spirit of this Agreement and/or that may be necessary for compliance with this Agreement.

SECTION 7. Further, both parties pledge their cooperation to manage this project in an effective and economical matter and shall cooperate with the other by executing any and all other documents and instruments as applies to the project.
