ORDINANCE NO. 2019-27

AN ORDINANCE ACCEPTING THE BID OF JD STRIPING & SERVICES, INC. FOR THE 2019 PAVEMENT MARKINGS PROGRAM AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the City of Willoughby Hills on February 14, 2019 by motion, granted the Mayor authorization to advertise for bids for the 2019 Pavement Markings Program; and

WHEREAS, the project was advertised in the News Herald on March 8th and March 15th as well as on the City's website; and

WHEREAS, invitations to bid were distributed to six pavement contractors and bid documents were distributed to The Builder's Exchange and ConstructConnect planrooms; and

WHEREAS, six contractors purchased bid documents and four contractors submitted bids by the March 28, 2019 deadline; and

WHEREAS, the bids of \$50,949.95 received from JD Striping & Service, Inc. is 15.6% below the Engineer's Opinion of Probable Construction Cost of \$60,378.00; and

WHEREAS, JD Striping & Services, Inc. fully understands the scope of work and is comfortable with their bid and has a good history of working with Richard L. Bowen & Associates on past projects outside of the City of Willoughby Hills, and

WHEREAS, the Council of the City of Willoughby Hills has reviewed and accepts the recommendations as provided by the City Engineer Pietro DiFranco and the Assistant City Engineer Kevin Trepal, P.E. in their Memorandum of April 2, 2019, attached hereto as the "**Exhibit A**", consisting of three (3) pages and incorporated herein by reference, finding the bid of \$50,949.95 submitted by JD Striping & Services, Inc. to be the lowest bid in conformance with all contract requirements.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor is hereby authorized and directed to accept the bid of and thereby enter into a contract with JD Striping & Services Inc. of 438 Beecher Avenue, Ravenna, Ohio 44266, for the 2019 Pavement Markings Program at a total cost not to exceed \$50,949.95.

SECTION 2. The Director of Finance is authorized and directed to return the bid bonds to all unsuccessful bidders.

SECTION 3. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 4. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual daily operation of the municipality and further reason to allow the City to accept the bid of JD Striping & Service Inc., thereby allowing for the immediate execution of the contract in order to proceed with the 2019 Pavement Markings Program; wherefore this Ordinance shall be in full force and take effect from and after its adoption and approval by the Mayor
