Order of Business

Bids for Sale of Notes

Our notes were priced by Stifel Nicolaus. Received excellent rates. The \$1,100,000 GO Note (for the PD Communication Center, Street Projects and the 2012 Fire Truck) came in at a coupon rate of 1.0% with a yield of 0.40% (last year's note was a 1.0% coupon with a yield of 0.50% - a reduction of .10%). The \$100,000 TIF Taxable Note came in at a coupon rate of 2.0% with a yield of 0.65% (last year's note was a coupon 1.625% coupon with a yield of .75% - a reduction of 0.10%).

2013 Budget

Seeing the impact in the losses of funding – at present, without further revisions, we would be at a deficit (but the budget is not completed – there is some additional pairing to get us to balanced budget). Extreme impact from external forces – lost \$200,000 in property valuation – spread by funds, but comes back to the general fund. Personal property tax reimbursements and SB3 reimbursements also eliminated and brought us down. Losing major income tax payer (Eaton) this year - \$200,000 reduction in revenue as well. First pass is a 200k deficit, but further revisions will be made to get us to a balance. Estimated 20% increase in cost of health care – hope that it will come in lower.

<u>Projecting Police Budget of approximately \$2.9 million</u> – actual obligations were approximately \$2.8 million in 2012. Fire Department – refund category noted because of the Cleveland Clinic reimbursement of past collected tax. Fund 234 – PT firefighters are funded primarily by the property tax levy. Increase in uniforms – slightly under-budgeted in 2012.

<u>Areas of Potential Cuts</u> – Public Works/Service Department. Needs to balance out the Street Fund – some road projects need to go in, some equipment will go out. Look at discretionary spending that can be put off – defer filling some open positions (Captain in FD, Service Department position) go through the year and evaluate the need. Hopeful that health care costs come in beneath budget. Next year – Affordable Health Care Act – will have to offer health care to certain positions.

<u>Overall Budgeted a 2% Increase on Income Tax</u> – down slightly in first two months of the year – estimate from other cities in that same range. Last two years – commercial taxpayer had made payments, but no liability – had some refunds to that taxpayer from RITA.
