#### **UNFINISHED BUSINESS**

President of Council asked if anyone would like to entertain a discussion about asking the County to raise our taxes by raising our valuations. President Reichelt stated that this was a first, and wanted to put it out there because we have never had anybody come and ask to pay more taxes.

Councilman Fiebig stated of course the value of individual real estate is a matter for the individual to take to the County and the County sets the valuations; it is done every six years. So City Council doesn't have anything to do with it. There is Lake County Auditor's Website and the information is there. If you would like, Councilman Fiebig can get you the number, you need to call and do that individually; Council can't take

action on that, just for the benefit of those who might have misconstrued what was said. Council doesn't have anything to do with the devaluation of property within its borders.

Law Director stated, absolutely, there is a separate form for the Board of Revision that the individual property owner has the right to bring forth. This is kind of unusual, Mr. Kowalsky's position that he is paying too little taxes and he wants to pay more taxes which is usually the opposite of what normally occurs; you want devaluation, so that you pay less taxes. He is upset that he has had his property value devalued; this is just the County's appraisal that is all that is, for setting taxes. That does not mean that in the market place, that his property can't sell for much less or greater, whatever it is. There is a Board of Revision, there is a process for it, and it has to be filed by the property owner. The Law Director advised Mr. Kowalsky to please do so, there is a time constraint when it must be done, it must be done in writing, and you also must give them proof as to why you believe the property should normally be devalued less, i.e. sales in the community, recent sales, an expert's report, or there have been improvements made to the property. It is an individual thing, this City nor any City that the Law Director knows of, and he represents other Cities, can and should do this and oh by the way, the real complaint is should be to the County Commissioners, because everybody's taxes have gone down, as the properties have devalued. Yes, the City's property has gone down more, because the Law Director thinks that it is a product of increases of so much more during the year of 2008. Again, it is an individual's own right and the Law Director advised Mr. Kowalsky to exercise his right. We have no providence in doing so at this time.
