A RESOLUTION TO RECOGNIZE AND HONOR FORMER COUNCILMAN, VETERANS MEMORIAL CHAIRMAN, AND LONGTIME WILLOUGHBY HILLS RESIDENT LARRY O'DONNELL THROUGH THE NAMING OF THE LARRY O'DONNELL AMPHITHEATRE AT VETERANS MEMORIAL PARK AT THE WILLOUGHBY HILLS COMMUNITY CENTER COMPLEX.

WHEREAS, Larry O'Donnell has served as Chairman of the Willoughby Hills Veterans Memorial Commission for many years at the behest of several Willoughby Hills Mayors; and

WHEREAS, Larry O'Donnell has worked tirelessly to ensure that ceremonies honoring Veterans and those who have lost their lives fighting for American's freedom on both Memorial Day and Veterans Day capture the spirit and solemnity of the auspicious occasions; and

WHEREAS, through Larry O'Donnell's efforts, the ceremonies surround those important holidays have received the attention of the City and surrounding communities; and

WHEREAS, through Larry O'Donnell's efforts the Veterans Memorial Park area has now become a fitting gathering place for residents of the City of Willoughby Hills to honor the fallen and veterans and also to enjoy concerts and municipal social occasion.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The City Council of Willoughby Hills hereby honors and recognizes Larry O'Donnell for his numerous contributions to the City and to its veterans.

SECTION 2. The area located adjacent to the Willoughby Hills Community Center Complex and Roemisch Field containing the benches, pavilion, and other park facilities shall be known forthwith as the Larry O'Donnell Amphitheatre at Veterans Memorial Park in recognition of Larry O'Donnell's years of service and dedication to the City of Willoughby Hills and to its veterans.

SECTION 3. This Resolution shall be in full force and effect at the earliest time permitted by law.
