Any such request for the calling of a Special Meeting and the notice thereof shall state the subject or subjects to be considered at the meeting, and no other subject or subjects shall be considered there, except on the approval of four or more of the members of Council in attendance at the Special Meeting. A member of Council who shall attend the Special Meeting shall be held to have waived the notice required by this rule.
