Ordinance 2012-61: Temporary Appropriations for the First Quarter of 2013 (through March 2013).

Allows us to move forward with a temporary appropriation – debt service requirements for the first three months of the year – look for a full year operating budget in January/February of 2013. Income taxes will be negatively affected with income tax projection for next year – loss of \$200,000 with Eaton Corporation leaving the City. Slight overestimation in income tax collections for 2012 – about \$150,000 less than what is projection – 2% has been reasonable in the past. Primarily where we fell short – net profits category – withholding tax has been up, indicating higher employment. 4.4 million dollars projected for 2013 – below projected for this year. Lose about \$110,000 in Local Government Fund revenue – certain degree that the State will fund at the same reduced level right now. State budget only goes through June 30 of this year – will have to see what happens in six months. Personal property taxes away from local governments. Big unknown still property taxes – based on preliminary valuations – down 10.5% for residences, 15% for cities – about a \$200,00 reduction – about a \$300,000 loss in revenue – income tax could be at about \$600,000. Internet cafes pay us \$5,000 registration and per machine every month – could be another \$150,000 reduction. No estate tax in Ohio after January 1<sup>st</sup>. Snowplow and financial system – those items are going to have to be funded by the General Fund – major challenges in the revenue side – normal challenge on operating side – health care, budgeting a 20% increase. Biro – plan for the worst, hope for the best.

## Order of Business

<u>Ordinances 2012-53</u> – Authorizing the Mayor to execute a contract for Professional Information Technology Services contract with Paragrid LLC. This Ordinance was briefly discussed at a previous meeting and was held in committee for research which resulted in the finding that the contract can be awarded without competitive bidding because it is considered, by the State Auditor, a professional service that is exempt from those rules. **It was the consensus of the Committee to waive the Three Reading Rule and recommend for Adoption at Thursday's Council meeting (Regular Council Meeting of December 13, 2013).** 

<u>Ordinances 2012-55</u> – Authorizing the Mayor to execute a Public Works Non-Emergency and Emergency shared services agreement to formalize our participation in this new program. It was the consensus of the Committee to waive the Three Reading Rule and recommend for Adoption at Thursday's Council meeting (Regular Council Meeting of December 13, 2013).

<u>Ordinances 2012-57</u> – Declaring an old snow plow truck as surplus and authorizing its sale. The vehicle is not in running condition and cannot be reasonably repaired. **It was the consensus of the Committee to waive the Three Reading Rule and recommend for Adoption at Thursday's Council meeting (Regular Council Meeting of December 13, 2012).** 

<u>Ordinances 2012-58</u> – Amending Section 941.07 to establish a new rate structure for rental of facilities at the Community Center. Councilman Malecek requested language be inserted regarding the manner in which the determination of non-sanctioned Civic Organizations is made. With that amendment agreed upon, it was the consensus of the Committee to waive the Three Reading Rule and recommend for Adoption at Thursday's meeting (Regular Council Meeting of December 13, 2012).

Ordinances 2012-59 – Amending Ordinance 2012-13 with revised appropriations to comply with the Ohio Revised Code. The Finance Committee will review this in more detail at their upcoming meeting on Thursday evening (before the council meeting) but it was the consensus of this committee to waive the three reading rule and recommend all for adoption at Thursday's Council meeting upon the approval of the Finance Committee. An upgrade of the Finance Department's Software System is included in this Ordinance and will be discussed in detail by the Finance Committee at their upcoming meeting on Thursday, prior to the meeting of City Council.

Ordinances 2012-60 — Authorizing the Mayor to purchase a used truck and snow-plow on an emergency basis at a total cost, including the plow and hitch, of approximately \$45,000.. The Mayor explained that the new trucks we ordered last year are still being outfitted and will not be ready until the end of December, at best. We've recently lost the service of some of our other trucks, so we do not currently have enough to handle a serious snowstorm. Thus, this is an emergency measure to keep our fleet ready. It was the consensus of the Committee to waive the Three Reading Rule and recommend all for Adoption at Thursday's Council meeting (Regular Council Meeting of December 13, 2012).

Ordinances 2012-61 — Creating the temporary budget and appropriations for the first quarter of 2013. The Finance Committee will review this in more detail at their upcoming meeting on Thursday evening (before the council meeting) but it was the consensus of the Committee to waive the Three Reading Rule and recommend for Adoption at Thursday's Council meeting (Regular Council Meeting of December 13, 2012) upon the approval of the Finance Committee.

Resolution 2012-14 — Approving a then-and-now certificate for the purchase of diesel fuel from Melzer's Fuel Service. The facts relating to this purchase and certificate were outlined in a memo to Council from the Finance Director, dated December 7, 2012. It was the consensus of the Committee to waive the Three Reading Rule and recommend for Adoption at Thursday's Council meeting (Regular Council Meeting of December 13, 2012)
