projects done several years ago. Last payment on existing Debt – Cushion budgetary impact of the new Note. Paying the new Note down in 2015 – Final Payment. Presented Council Clerk with estimated useful life of the Assets. Maturity would be close to maturity of existing Note – combine this Note in with existing Note. Minimizes Issuance Cost. Cannot Bid the Note until after this passes, once the Note is passed – underwriter can market the issue. Once sign the Purchase Agreement.

#### **General Status of Finances/Health Care Plans for 2014**

In the process of dealing with Health Care providers – currently covered by Anthem – came back with a 49% increase – over 200k a year cost to the City. Went back to market – given our history – three large providers declined coverage. Identified Kaiser – provided with a proposal of annual about 10k over what we are currently paying to Anthem. Anthem came back with a 22% increase – that proposal would cost about 100k more a year. Kaiser proposal, the benefits are comparable. Any final decision has to be approved by Health Care Committee. Half this year and half in 2014 – Budget had prepped for 20% increase. No increase for Gap Insurance in Budget. Kaiser – decrease of 34k. Anthem proposal does not change level of Health Care deductible levels. Kaiser proposal lowers deductibility for employees.

<u>Reichelt</u> – Gap Coverage reduced, but Kaiser still a slight increase. Will need to appoint a Council Representative to be on the Committee. Monday, 10:00am. Council President Reichelt or Councilman Biro will represent at the meeting.

#### **Internet Café**

Three in the City right now – still planning to stay in business as the referendum. In general doing well on expenses side – salt consumption was higher than anticipated – significant thing on the Agenda. Difference – Expenditure Adjustments – Budget was so tight. Income Tax seems to be running on target. Estimate for changes in the Taxpayer Base – hopeful to have some spike in collections.

Frank needs more time to devise any type of numbers – cautious to come up with dollar figure. It is about usage and consumption. One based on utility values – Finance Committee. Neither should be saddled – rational decision about consumptions – and precedent/past practice.

Presentation from Amy Holtshouse Brennan, Director Chagrin River Watershed Partners regarding Willoughby Hills Stormwater Retrofit Demonstration at the Willoughby Hills Community Center and Library Funded by Ohio EPA Surface Water Improvement Fund 9SWIF) Grant. CRWP's proposed monitoring of the stormwater retrofits in the Community Center Parking lot will incorporate pervious pavers into two sections of the parking lot. CRWP has funding to monitor several stormwater practices to better understand how they function and ultimately to better design and maintain these systems. This monitoring is part of a larger project ath includes many different components. More information is available on our Website at <a href="http://bit.ly/11kF2KA">http://bit.ly/11kF2KA</a>

**Background:** The City of Willoughby Hills was awarded an \$80,750 Ohio Environmental Protection Agency Surface Water Improvement Fund Grant in 2012 to construct 2,500 square feet of bio retention and 2,400 square feet of pervious paver stormwater retrofits within the Willoughby Hills Community Center and Library parking lot located at 34500 Chardon Road to demonstrate the benefits of stormwater retrofit best management practices to public officials, local commercial business owners and the over 50,000 local residents who visit the Community Center annually.

This project will also be part of CRWP's National Estuarine Research Reserve Science Collaborative Research Initiative that seeks to validate the effective stormwater runoff reduction capacity of infiltration practices such as bio retention cells and pervious pavements. The Willoughby Hills Community Center project, which is scheduled for construction in 2013, will be instrumented with monitoring equipment to measure hydrologic characteristics of the project as well as climate data specifically for the site, all of which will be utilized to model stormwater runoff quantity reduction capacity based on projected climate change scenarios. <a href="http://bit.ly/143T6tW">http://bit.ly/143T6tW</a>

This helps promote the infiltration of stormwater. Use of bio-retention and monitoring, used in Solon, Russell, in 2009 saw a reduction of 33%; in 2010, a 60% reduction in funoff. Hav Grant – CRWP/NERR Science Collaborative Project. Data used to better inform how these practices are working, and how to regulate them. Various entities have differing methodology. Also to collect for maintenance impact research. Have 6 sites – WH is one of six. Map, diagram, displayed. How much water comes through, and into the pipe, soil sensing meter into the gravel. Device is a V-notch weir box – gathered by HOBO data loggers. Will also detect salt concentration. Contractor Biohabitats, Inc. in Little Italy and No Carolina University. Above ground – Placed in a wood box and weather station.

Required of the City: CRWP needs to be involved at construction. Want records of sweeper or plowing. She discussed with Nate. Chairman Fiebig: Asked for a copy of PowerPoint Presentation and will request Administration to provide on the City Website. Who is contracting? On Agenda soon. ## Review of City Engineer Status Report of May 2, 2013

Veterans Memorial Park – The gazebo, bridge and benches are in place. Look to modify bridge. This is certainly an enhancement to our City.

## **Rogers Road Slope Stabilization**

City Engineer DiFranco has coordinated with CT and Marous for repairs which have been completed. We have requested and are awaiting a final report from CT Consultants. The Mayor indicated that our request for \$94k and \$60k from Lake County Storm Water Management has been already approved for this project. A waiting a written 2 year warranty.

## **Euclid Creek East Branch (Lamplight Lane)**

City Engineer DiFranco has had discussions with the Mayor and Tim Miller from Lake County, reviewed CT's initial report from 2000 with more recent plans within the last year that have included a Dike Structure. Area is identified as a Flood Plan. City Engineer would like to review the Dike Plans for cost and efficiency. May proceed with replacing a larger culvert, but look to other ways to mitigate flooding. Also, look toward downstream concerns as well.

#### **Knecht/O'Brien Culvert on Eddy Road**

This is a situation where a culvert was installed by a resident that has collapsed. Now water floods backyards onto Eddy Road. Plans to repair – must be restored as original condition with conservation easement. Project to remove concrete. Lake County Storm Water to Fund - \$200,000. Need authorization for design and bidding to replace the two culverts on Lamplight.

## Cricket Lane

The storm sewer on the Westside over flows. Nate is looking to sublet this job out. Our cost of \$24,500 will be reimbursed by the Lake County Storm Water Management Program.

## **2013 Pavement Markings**

Project awarded to Pat Flowers for a cost of \$26,535.10 (Council already approved). To begin May 20<sup>th</sup> with a two month finish at July 20, 2013.

## **Maple Grove and Dodds Landing Pavement Projects**

Bid opening May 23, 2013

## **Euclid Creek Tributary Watershed Sanitary Sewers**

In depth discussion concerning the back flowing of water from behind Giant Eagle with subsequent basement flooding on Bishop and in Strafford Place on Chardon. Currently there is no plan in place as many options need to be considered along with cost. An underground holding tank behind Giant Eagle most likely to be considered first, then look for continued correction. There are also issues aligned with storm water infiltration.

## **Maple Valley Subdivision**

Proposed subdivision, City Engineer is working with developer, engineer and architect. City Engineer will be reviewing the storm water calculations from the developer to resolve storm water issues and concerns.

## **Clover Congregate Senior Living Care**

This project is still in the Planning Commission stage.

## **Pleasant Valley Road Bridge**

The City has been contracted by the County Engineer; suggested that the bridge be closed during the winter months. Corrosion has been noted, and it may be from salt interacting with the steel. Load rating should be inspected every two years. The County has a responsibility to inspect all bridges; the City owns the bridge, therefore, responsibility of maintaining the bridge lies with the City. Discussion is to follow with the County's Bridge Exert and the company that restored the bridge.

#### Rosewood Trail

A City culvert pipe overflowing has caused erosion near a home (this is part of the Euclid Creek Project).

#### **Fowler Drive**

Lake County Stormwater Management to review creek near Sturgil's home for proper drainage.

#### **Additional Road Projects**

- (1) **Gatsby** the pavement at the intersection of Gatsby and Kristin needs repair, estimated cost is \$108,000 which should include contingency, design and engineering. The concrete (material) and labor are to be bid out.
- (2) Hanna this is an asphalt road to be overlaid with 2" of new asphalt. A portion from Parsons to the cul-de-sac needs to be widened and will be done by our Service Department. Need to look for Funding (a Short-Term Note), to borrow \$250,000 and pay it back in 5 years with Road Levy monies. Committee recommends to Council to check with the Finance Director for funding this Project.
- (3) Lastly, the City is looking to repair **Glen Kyle** cul-de-sac with high strength dura bond to fill in the cracks.
