At the request of Councilman Somich, the Law Director provided the following explanation as to why the City was adopting the zoning change required in Ordinance No. 2012-46. The Law Director explained that the

property involved is the Mazda-Volkswagen Dealership and the property was previously zoned "commercial". In 2006, zoning code changes were made; subspecialties were created B1, B2 and B3. Technically the property was zoned B2 which would make the Mazda Dealership nonconforming as currently constituted. As one faces the Mazda Dealership there is a small strip-center. The Dealership desired to expand both the Mazda and Volkswagen and come into conformity with the franchise. The Dealership wanted to stay in the City and required both parcels to be B3. Pursuant to City Charter, the issue could be addressed either by referendum or through litigation. The Agreed Judgment Entry changes the zoning and allows the Dealership to stay in Willoughby Hills. If they didn't get the zoning change, there was some decision that they would be leaving the City. Instead of leaving the City, the Dealership is going to expand, almost to double the size, and hopefully it will give some vitality to the west-end. The Dealership still is required to come before the Planning and Zoning Commission for all the requisite approvals and the only thing that the City cannot hold back on is that the zoning would be improper. This is only the provision to allow the Dealership zoning to expand.

President Reichelt stated that it was adjudicated by the Common Pleas Court; essentially, although the City is ratifying the Agreed Judgment Entry, we don't really have much choice in matter. The Law Director stated technically would be correct.
