## ORDINANCE NO. 2012-55

---

### **AN ORDINANCE ADOPTING THE OHIO PUBLIC WORKS NON-EMERGENCY AND EMERGENCY SHARED SERVICES AGREEMENT AUTHORIZING INTERGOVERNMENTAL SHARED SERVICES AND THEREBY ESTABLISHING A COUNTYWIDE PUBLIC WORKS SHARING AND USE PROGRAM.**

**WHEREAS**, county and local governments in Lake County, Ohio seek to enter a Shared Services Agreement in order to provide for the sharing of resources, personnel, and equipment; and

**WHEREAS**, the Parties to this Agreement recognize the need for increased efficiency in local government, intent to realize gains from specialization, and are actively pursuing means to reduce financial strain on their citizens; and

**WHEREAS**, the Parties to this Agreement wish to engage in a Shared Services Agreement, while holding each other harmless, indemnify each other against third-party lawsuits, and enhance Workers Compensation protection; and

**WHEREAS**, the Parties recognize the necessity to provide mutual aid and contingency assistance during emergencies; and

**WHEREAS**, this Agreement is made pursuant to Ohio Revised Code Section 9.482, which authorizes a political subdivision to enter into an agreement with another political subdivision, whereby a contracting political subdivision agrees to exercise any power, perform any function, or render any service for another contracting Borrower political subdivision that the contracting Borrower political subdivision is other legally authorized to exercise, perform, or render; and

**WHEREAS**, said Agreement, as prepared by the State Auditor, fulfills the written consent requirement of Ohio Revised Code Section 9.482 authorizing intergovernmental shared services.

***NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:***

**SECTION 1.** Pursuant to Ohio Revised Code Section 9.482, the Mayor is hereby authorized and directed to execute the ***Public Works Non-Emergency and Emergency Shared Services Agreement*** attached hereto as Exhibit "A" consisting of five (5) pages and incorporated herein by reference.


**SECTION 2.** The actions of this Council concerning and relating to the passage of legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.
