## ORDINANCE NO. 2014-13 – AS AMENDED

#### AN ORDINANCE AMENDING SECTION 1 OF <u>ORDINANCE NO. 2013-43</u> TO COMPLY WITH STATE BUDGETARY LAWS REQUIRING MUNICIPALITIES TO MAINTAIN POSITIVE ACCOUNT BALANCES THROUGHOUT THE YEAR BY PROVIDING FOR 2014 OPERATING BUDGET REVISIONS SPECIFICALLY FOR THE KNECHT/O'BRIEN CULVERT STREAM RESTORATION PROJECT AND REPEALING CONFLICTING LEGISLATION.

WHEREAS, on January 23, 2014 the Council of the City of Willoughby Hills adopted <u>Ordinance No.</u> 2014-5 amending Section 1 of <u>Ordinance No. 2013-43</u> providing for permanent appropriations necessary to maintain City services for the fiscal period beginning January 1, 2014 through December 31, 2014; and

**WHEREAS,** on February 13, 2014 the Council of the City of Willoughby Hills adopted <u>Ordinance No.</u> <u>2014-15</u> amending Section 1 of <u>Ordinance No. 2013-43</u> providing for permanent appropriations necessary to maintain City services for the fiscal period beginning January 1, 2014 through December 31, 2014; and

WHEREAS, Ordinance No. 2014-12 amended Section 1 of Ordinance No. 2013-43 by providing for permanent appropriations necessary to maintain City services for the fiscal period beginning January 1, 2014 through December 31, 2014; and

WHEREAS, pursuant to the Interoffice Memo from Finance Director Brichacek dated February 7, 2014, consisting of one (1) page, attached hereto as **Exhibit "B"** and referenced herein stating that this ordinance would provide for the following appropriation revision: Increasing the appropriation of the Street Construction, Maintenance and Repair Special Revenue Fund No. 250 to provide for the unobligated portion of the Knecht/O'Brien Culvert Stream Restoration Project; removal of a deteriorated/collapsed 225 foot, 24 inch culvert and restoration of the natural drainage channel to alleviate frequent storm water flooding affecting the properties located at 29329 and 29341 Eddy Road; the award amount is comprised of \$21,750 for engineering as proposed by Richard L. Bowen Associates, Inc. and an estimated construction budget of \$180,000; and

WHEREAS, on February 20, 2014 the Finance Director submitted a revised *Schedule of 2014 Appropriations*, marked as the <u>REVISED</u> EXHIBIT "A"; and
