AN ORDINANCE REAUTHORIZING A COOPERATION AGREEMENT BETWEEN THE CITY OF WILLOUGHBY HILLS AND THE BOARD OF COUNTY COMMISSIONERS, LAKE COUNTY, OHIO ON BEHALF OF THE CITY OF WILLOUGHBY HILLS IN ORDER TO PARTICIPATE IN THE LAKE COUNTY, OHIO DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT ENTITLEMENT PROGRAM AND ABIDE BY THE COVENANTS OF SAID PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, the Housing and Community Development Act of 1974 as amended, provides an entitlement of funds for community development purposes for urban counties; and

WHEREAS, Lake County will be designated as an "Urban County" provided that it secures the continued commitments with various political subdivisions in Lake County; and

WHEREAS, the Mayor and Council of the City of Willoughby Hills may desire the use of "CDBG Urban County Entitlement Funds" for needed public improvements in Lake County and its municipalities; and

WHEREAS, the County shall prepare Applications for FY2015, 2016 and 2017 Urban County Entitlement Funds pursuant to the aforementioned Act for the FY'2015, 2016 and 2017 Program Years; and

WHEREAS, the City of Willoughby Hills desires to reaffirm its participation and inclusion of its population in the Lake County Community Development Block Grant and HOME Investment Partnership programs and to reauthorize the Cooperation Agreement with the Board of County Commissioners for an additional three-year period.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Cooperative Agreement with the Board of County Commissioners of Lake County, Ohio consisting of three (3) pages, attached hereto and incorporated herein as the "EXHIBIT A" is hereby reauthorized; the period of time of this agreement shall be from the first day of the 2015 program year, through and including the last day of the 2017 program year and is being entered into for the purpose of cooperating and participating in the Lake County HUD Entitlement Program per the Housing and Community Development Act of 1974 (Public Law 93-383), 42 U.S.C. 5301, as amended, and Section 570.105 b 3 (iii), Community Development Block Grant Program Rules and Regulations.

SECTION 2. The Mayor serving as Chief Executive Officer of the City is hereby authorized to sign said Cooperation Agreement and to take such actions as are necessary or appropriate to consummate or implement the transaction described in or contemplated by this Ordinance.

SECTION 2. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the community, and for the further reason to comply with the tight deadline by which said Agreement must be submitted to HUD, the County has requested that the Cooperative Agreement be executed on or before September 19, 2014; wherefore this Ordinance shall be in full force and take effect immediately upon its approval by the Mayor.
