ORDINANCE NO. 2014-69

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO A CONTRACT(S) FOR GENERAL LIABILITY INSURANCE COVERAGE FOR THE CITY OF WILLOUGHBY HILLS AND DECLARING AN EMERGENCY.

WHEREAS, Council accepts the recommendation of the Mayor to approve the revised quote, dated October 8, 2014, submitted by HHC Public Risk Ohio (U.S. Specialty Insurance Company) for General Liability Insurance Coverage for the City.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor shall be, and is hereby authorized and directed to enter into a contract or contracts for General Liability Insurance Coverage at a premium or premiums not to exceed **Ninety-Four Thousand, Seventy-Nine Dollars (\$94,079.00)** pursuant to the terms and conditions as identified in the revised renewal quotation of HHC Risk Ohio (U.S. Specialty Insurance Company), dated October 8, 2014, consisting of two (4) pages attached hereto as the **Exhibit "A"**, and incorporated herein by reference.

SECTION 2. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it further provides for the usual daily operation of a Municipal Department, to wit: the continuance of General Liability Insurance Coverage for the City; wherefore, this Ordinance shall be in full force and effect upon and after its passage and approval by the Mayor.




