## ORDINANCE NO. 2014-70

---

### **AN ORDINANCE AMENDING ORDINANCE NO. 2011-4 IN ORDER TO ADJUST THE MINIMUM HOURLY RATE AND TO ELIMINATE THE REQUIRED STAFFING LEVEL FOR THE POSITION OF PART TIME CITY PROPERTY STAFF MEMBER AND REPEALING CONFLICTING LEGISLATION.**

**WHEREAS**, on January 27, 2011 the Council of the City of Willoughby Hills adopted Ordinance No. 2011-4 establishing and fixing a compensation range for the position of Part Time City Property Staff Member; and

**WHEREAS**, the required staffing level for said position was initially set to be up to ten (10) Part Time City Property Staff Members; and

**WHEREAS**, the Working Committee of Council met on October 14, 2014 and has determined that: (1) the minimum hourly rate for the Position of Part Time City Property Staff Member shall reflect the minimum wage as prescribed by State Law and (2) the Staffing Level for said position should be fixed by Administration.

**NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:**

**SECTION 1.** The minimum hourly rate for the Position of Part Time City Property Staff Member shall be the minimum wage as determined and set by State Law.

**SECTION 2.** The Administration shall determine the responsibilities and staffing level of the established position of Part time City Property Staff Member for said position shall report directly to a member of Administration.

**SECTION 3.** All Ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as of the effective date of this Ordinance.

**SECTION 4.** All the actions of this Council concerning and relating to the passage of this legislation were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 5.** This Ordinance shall be in full force and take effect at the earliest time permitted by law.
