ORDINANCE NO. 2014-79

AN ORDINANCE DIRECTING THE MAYOR TO SIGN ANY AND ALL NECESSARY DOCUMENTS TO SECURE THE PURCHASE OF POLICE VEHICLES FOR BUDGET YEAR 2015 THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING AGREEMENT CONTRACT WITH SAID PURCHASE BEING EXEMPT FROM COMPETITIVE BIDDING PURSUANT TO SECTION 125.04 (C) OF THE OHIO REVISED CODE AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to the Police Department Memorandum from Police Chief Christopher J. Collins to Mayor/Safety Director Robert M. Weger, dated December 2, 2014, Police Chief Collins has respectfully requested approval for the purchase of three (3) new police vehicles for Budget Year 2015 through the State of Ohio Cooperative Purchasing Agreement Contract No. RS901214, effective 10/11/2013 to 09/30/2014, renewed through 09/30/2015; and

WHEREAS, in accordance with State Contract Law Enforcement Vehicle Specifications and pricing with available options, two 2015 Ford Utility Police Interceptors are to be purchased from State Wide Ford, 1108 West Main Street, Van Wert, Ohio 45891, cost with options and delivery would be **\$25,867.50** each, for a total vehicle purchase price of **\$51,735.00**; these cars would be assigned to the Patrol Division; and

WHEREAS, a 2015 Chevrolet Impala Police Model is to be purchased from Byers Chevrolet, 555 Broad Street, Columbus, Ohio, 43215, cost with options and delivery would be **\$20,557.00**; this car would be assigned to the Detective Bureau; and

WHEREAS, said vehicle costs do not include equipment changeover, the installation and decaling which the Police Chief has estimated to be an additional **\$32,000.00**; and

WHEREAS, Police Chief Collins has submitted a total budget request of \$104,036.00 for the Department's 2015 Police Vehicles; and

WHEREAS, based upon the Mayor's approval of Chief Christopher Collins' request for purchase of two (2) 2015 Ford Utility Police Interceptors and one (1) 2015 Chevrolet Impala Police Model, the Council of the City of Willoughby Hills is in agreement with the immediate purchase of said vehicles by utilizing funds from #234 – Safety Forces Special Revenue Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor is hereby authorized and directed to sign any and all necessary documents to secure the purchase of: two 2015 Ford Utility Police Interceptors from State Wide Ford, 1108 West Main Street, Van Wert, Ohio 45891, at a cost of **\$25,867.50** each, for a total vehicle purchase price of **\$51,735.00** and one (1) 2015 Chevrolet Impala Police Model to be purchased from Byers Chevrolet, 555 Broad Street, Columbus, Ohio, 43215, at a cost of **\$20,557.00**. Said purchase costs do not include equipment changeover, installation and decaling.

<u>SECTION 2</u>. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the Police Department, and further reason being that this will allow the City to order three (3) police vehicles through the State of Ohio Cooperative Purchasing Agreement Contract by January 5, 2015; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
