AN ORDINANCE ACCEPTING THE BID OF SPECIALIZED CONSTRUCTION, INC. OF CUYAHOGA HEIGHTS, OHIO FOR THE EDDY ROAD RESURFACING PROJECT AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the City of Willoughby Hills on November 13, 2014 by motion, granted the Mayor authorization to advertise for bids for the Eddy Road Resurfacing Project from I-271 to Rockefeller after the estimates had been prepared by the City Engineer; and

WHEREAS, bids received on March 26, 2015 ranged from a low bid of \$192,358.75 to a high bid of \$300,316.00 as compared to the Engineer's Opinion of Probable Construction Cost of \$210,000.00; and

WHEREAS, the Council of the City of Willoughby Hills has reviewed and accepts the recommendations as provided by the City Engineer Pietro DiFranco, in his Memorandum of April 7, 2015, attached hereto as the "Exhibit A", consisting of ten (10) pages and incorporated herein by reference, finding the bid of \$192,358.75 as submitted by Specialized Construction, Inc. of Cuyahoga Heights, Ohio to be the lowest and best bid in conformance with all contract requirements.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:


SECTION 1. The Mayor is hereby authorized and directed to accept the bid of and thereby enter into a contract with Specialized Construction, Inc. of 711 Harvard Avenue, Cuyahoga Heights, Ohio, for the Eddy Road Resurfacing Project at a total cost not to exceed **\$192,358.75**.

SECTION 2. The Director of Finance is authorized and directed to return the bid bonds to all unsuccessful bidders.

SECTION 3. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 4. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual daily operation of the Municipality and further reason to allow the City to accept the bid of Specialized Construction, Inc. thereby allowing for the immediate execution of the contract in order to proceed with the Eddy Road Resurfacing Project; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.


