A RESOLUTION ACKNOWLEDGING CITYMUSIC CLEVELAND FOR TEN YEARS OF MUSICAL ENRICHMENT TO THE NORTHEASTERN OHIO AREA.

WHEREAS, CityMusic Cleveland is an American Chamber Orchestra based in Cleveland, Ohio; founded in 2004, by six friends who strongly believed that music should be enjoyed by every citizen, young and old; and

WHEREAS, composed of professional free-lance musicians from the Cleveland area and beyond, to give free concerts throughout the Northeast Ohio area, the orchestra partners with community leaders, mayors, council members, and local civic organizations, to expand the audience for cultural events; and

WHEREAS, by and through partnering with city leaders to enrich the cultural offerings of their communities, CityMusic Cleveland has presented the finest quality performances of classical repertoire to the residents of several area communities, including Willoughby Hills; and

WHEREAS, the City of Willoughby Hills wishes to acknowledge CityMusic Cleveland for ten years of musical enrichment to the Northeastern Ohio area.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The City of Willoughby Hills gratefully acknowledges CityMusic Cleveland for ten years of musical enrichment to the Northeastern Ohio area and for partnering with the City of Willoughby Hills to enrich the cultural offerings of its residents by presenting the finest quality performances of classical repertoire.

SECTION 2. SECTION 3. This Resolution shall be in full force and effect at the earliest time permitted by law.




