RESOLUTION NO. 2013-26

A RESOLUTION HONORING COUNCILMEMBER DAVID A. REICHELT FOR HIS LEADERSHIP AND HIS DEDICATED SERVICE TO THE CITY OF WILLOUGHBY HILLS.

WHEREAS, David A. Reichelt answered the call to public service, was appointed and took office as Council Member in January 2004, elected to a serve a four-year term by the voters of Willoughby Hills in November of 2005 and was re-elected in November of 2009 to serve his final term; and

WHEREAS, during his ten year tenure, Council Member Reichelt served with honor and integrity both in his capacity as Vice President of Council (2008-2011) and President of Council (2012-2013) and as Chair of various Standing Committees of Council; and

WHEREAS, Council Member Reichelt also served as the City's representative on numerous local and regional governmental bodies including the Planning & Zoning and Architectural Board of Review Commission, Council Ad-hoc Committee Against Any and All Expansion of the Cuyahoga County Airport, and the Cuyahoga County Airport Noise Abatement Council; and

WHEREAS, his role on the City of Willoughby Hills Council contributed much to the betterment of the future of Willoughby Hills for all of its residents by leaving a legacy of positive change, among them, the founder and chair of the Public Relations and Communications Ad-hoc Committee of Council, establishment of the WH Community Art Gallery, implementation of the City's long-awaited Master Plan and the updated Zoning Code to logically control development, and was responsible for the vision, planning, execution and dedication of the Veteran's Memorial Park; and

WHEREAS, Councilman Reichelt, serving as the Technology Consultant and Project Manager, spearheaded the renovation of the City's Public Safety Emergency Dispatch Center, donated countless hours of professional services to execute the renovation and continued to donate his professional services to maintain the Dispatch Center; and

WHEREAS, Council Member Reichelt always maintained a focus on the public good and acted to protect the public interest while donating countless hours of time, energy and personal commitment to better and enrich the lives of the residents of the City of Willoughby Hills; and

WHEREAS, his knowledge, expertise and dedication have served to promote the safety and well being of the citizens who live and work in the City of Willoughby Hills and although Council Member Reichelt leaves office in November 2013, we will remember him for his excellent work and for his selfless dedication and immeasurable contributions to the City and its residents.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:
