RESOLUTION NO. 2015-2

A RESOLUTION AUTHORIZING THE SUBMITTAL OF AN APPLICATION TO PARTICIPATE IN LAKE COUNTY'S 2015 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM TO SEEK FUNDING IN THE AMOUNT OF \$10,000 FOR THE INSTALLATION OF ADA ACCESSIBLE DOORS FOR CITY HALL POLICE DEPARTMENT AND DECLARING AN EMERGENCY.

WHEREAS, the Department of Housing and Urban Development (HUD) provides Community Development Block Grant Entitlement Communities Grants; and

WHEREAS, the Program provides annual grants on a formula basis to entitled cities and counties to develop viable urban communities by providing decent housing and a suitable living environment, and by expanding economic opportunities, principally for low- and moderate-income persons; and

WHEREAS, the Department of Urban Development (HUD) awards grants to entitlement community grantees to carry out a wide range of community development activities directed toward revitalizing neighborhoods, economic development, and providing improved community facilities and services; and

WHEREAS, Lake County will be submitting the FY 2015 Action Plan, as part of the 2015-2016 Consolidated Plan, to the Department of Housing and Urban Development (HUD); and

WHEREAS, the City of Willoughby Hills wishes to participate in the Lake County Competitive Community Development Block Grant Program FY2015, seeking funding in the amount of **\$10,000** for the installation of ADA accessible doors for City Hall Police Department Entrance.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor is hereby authorized and directed to submit an application on behalf of the City of Willoughby Hills to participate in the Lake County Community Development Block Grant Program FY2015 seeking funds in the amount of **\$10,000** for the installation of ADA Accessible Doors for City Hall Police Department.

SECTION 2. The actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This Resolution constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual daily operation of the Municipality and further reason to comply with the application deadline of **4:00pm on Monday, May 18, 2015**; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
