## ORDINANCE NO. 2013-39

### **AN ORDINANCE PROVIDING FOR THE SALE OF PERSONAL PROPERTY NOT NEEDED FOR MUNICIPAL PURPOSE AND DECLARING AN EMERGENCY.**

**WHEREAS**, on December 13, 2012, the Council of the City of Willoughby Hills adopted Ordinance No. 2012-55 to enter into a Shared Services Agreement authorizing Intergovernmental Shared Services, establishing a Countywide Public Works Sharing and Use Program in order to provide for the sharing of resources, personnel and equipment; and

**WHEREAS**, the Village of Grand River requested the use of the City's 1989 Sutphen Fire Pumper as the Village's Fire Pumper was out of service; and

**WHEREAS**, In accordance with Ohio Revised Code, Section 735.053, the Council of the City of Willoughby Hills desires to sell said Fire Pumper to the Village of Grand River, Ohio.

**NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:**

**SECTION 1.** The following City vehicle with an estimated value of \$20,000 be and is hereby declared to be surplus property of the City.

**1989 Sutphen Fire Pumper (VIN#1S9A1BBDXK1003649)  
Adjusted mileage of 127,300 – Factors in Actual Mileage with Engine Hours  
Estimated Value: Approximately \$20,000.000**

**SECTION 2.** In accordance with Ohio Revised Code, Section 735.053, the Mayor is hereby authorized to sell the property described herein for a maximum amount of Twenty-Two Thousand, Five Hundred Dollars (\$22,500.00) to the Village of Grand River, Ohio.

**SECTION 3.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 4.** This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the city of Willoughby Hills insofar as it provides for the usual daily operation of the Municipality, and further reason being that the Village of Grand River, Ohio can immediately benefit from the acquisition of the 1989 Sutphen Fire Pumper; wherefore, this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.




