### ORDINANCE NO. 2010-7 - SECOND READING

AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE ELECTORS OF THE CITY OF WILLOUGHBY HILLS A PROPOSED AMENDMENT TO THE CHARTER OF THE CITY PROVIDING FOR AN INCREASE IN THE RATE OF THE MUNICIPAL INCOME TAX TO TWO AND ONE-QUARTER PERCENT (2.25%) AND A TAX CREDIT OF ONE HUNDRED PERCENT (100%) WITH SAID CREDIT LIMIT TO BE EQUAL TO ONE AND EIGHTY-FIVE HUNDREDTHS PERCENT (1.85%) AND DECLARING AN EMERGENCY.

President Malecek stated that Ordinance No. 2010-8 will remain on Second Reading.

Law Director Lobe stated for the record that Ordinance No. 2010-7 has been modified on some minor technical, procedural points, there have been no substantive changes, and there are no changes in the legislative aspect that is why it is to remain on Second Reading. As a matter of law, whenever there is a ballot question, the Lake County Board of Elections as well as the Ohio Secretary of State has the right to revise the question. Law Director Lobe received some written suggested changes from the Lake County Board of Elections; one of the changes was to eliminate the written numeric reference for the question becomes too wordy. It was also suggested that the ballot question read "yes" or "no". Both the Board of Elections and the Ohio Secretary of State try to simplify the question and eliminate any confusion.
