• SOM Center Signalization Project – ODOT Meeting – Bid Opening March 11th – all Change Orders, all Processing Change Orders, any extra costs, that go over, above and beyond, the City's allocation, will be borne by the City and the project will not proceed unless the Change Order is paid. City needs to be mobile to address those situations if they were to occur; you may or may not know, the City Engineer has requested the City to budget a certain amount for this project, on a local side, as a contingency. The Engineer still thinks that the budget is going to work, but will summarize, in just a "one-pager", an outline of the costs as currently estimated, with contingencies and identify what contingency fund the City should have available, might suggest that the contingency fund require legislation to allow the Mayor to spend up to that maximum

to eliminate any delays in issuing, if there are legitimate Change Orders issued by the contractor on the project, up to a maximum allowable amount

Discussion of the General Fund

- Finance Director distributed a fourteen (14) page analysis of graphs and schedules comparing 2008/2009 actual numbers with 2010 projected budgets. Discussed major changes including tax income reductions and extra payroll period expense.
- Expense cuts were made totaling several hundred thousand dollars. Also holding off purchasing two (2) police cars: note concern for new fire pumper needed within 2-3 years
- City minimum carryover should be 10% (2 payrolls)
- Started 2010 with about 11%
- Estimates now show deficit for 2010 budget of \$586,000
- Proposed scenarios of income tax changes or a real estate levy (which would not render revenue until 2011)
- Must vote by 2nd Council Meeting of February to have an issue on Primary Election Ballot
- At 6:48 p.m. Councilman Fiebig motioned to adjourn into Executive Session, Councilwoman Fellows seconded. Finance Committee adjourned into Executive Session for the purpose of discussing possible changes in personnel.
