Tax Budget - Ordinance No. 2009-59

Status of Revenues

Real estate tax income improved a little; City Tax Revenue still slow, working with CCA/RITA transition; RITA will canvass all City businesses

Status of Expenses

Six (6) stimulus workers not paid by City; no overtime; watching hours; some retirements/attrition may not be replaced; upcoming purchases for equipment/supplier will be watched closely; will review heavy trash pickup bids before approving; other cuts may be necessary – administration will keep us aware of such changes

Clarification of all Sewer Funding

All funds are restricted and only used in sewers – maintenance, building, equipment, stabilize to reduce the need for rate increases

State Auditors on Site – Reviewing 2006

City is hopeful they will stay or return soon to audit 2007 and 2008 – we are ready for them

WHISPER Fund and Garfield Fund

State Auditor approved two (2) accounts for restricted funds – WHISPER and Garfield Funds

Financial Reports

Accounts from May have been reviewed, as well as all reports, analyses and Cash Reconciliations; financial reports for June were received today and will be reviewed in the future

COMMITTEE MEETING OF JULY 6, 2009

<u>Members Present</u>: President Kevin D. Malecek, Chair, Councilman Frank A. Germano, Vice President David A. Reichelt

Purpose of the Meeting was to discuss Pending Legislation and any other business.

The meeting convened at 6:38 p.m.

Order of Business

Property Maintenance Code – consultation with Law Director Lobe and Building Inspector Wyss.

<u>Lobe</u> – Chapter 1337 – two pages long – penalty section – Exterior Maintenance Code (1337.02) twenty lines long – passed in 1967 – since his tenure, and prosecutors before – it's too minuscule, not strong enough – even for unsafe structure – debases neighborhood/reduces property values – would we have to bring in a realtor.

<u>Prosecutor Germano</u> – not worth anything – if you give us something, give us the International Code – let's put faith in Building Department – get complaints all the time – weeds, tall grass – not in there. So limited in nature. We should adopt International Code – can strike out specific things out of the Code. Can always revoke it in the future.

International Code can be adopted piecemeal – adopted amendments from there – under Home Rule, you can take things out – generic Code good across the state – commentary about specific things – too much power to Building Inspector, etc – good for discussion purposes. May want to modify it. When we had Comprehensive Plan, David Hartt did not modify this – too much to do – his recommendation was to adopt International Code.

Mr. Wyss – reinforce what Law Director has stated – read strong letter to property owner – strong as we can get out of the Code. Can't be a subjective ordinance – suggest – lawns and weeds, landscape maintenance.

<u>Reichelt</u> – question for Mr. Wyss – we could set that grass level at any level? <u>Wyss</u> – kept old lawn ordinance even after they passed the International Code – something in an ordinance for City to cut the grass if property owners do not do it. Need to have a process – start with a conversation or friendly letter, but we need to have an endpoint and direction.

Need to have specific things asking for when looking for compliance. Generated by complaint – applying from generalities now. Sweets and Treats good example – three ordinances that the sign had to come down – someone does not want to comply – did not want to proceed. We are not going to have problems with this Code with the average citizen in Willoughby Hills.

<u>Reichelt</u> – in the last year, how many times do you think we would have been in Court? Gotten to that on any of them, if International Code in place. <u>Lobe</u> – most people come to their senses and understanding, or we learn there is a problem why they can't comply. <u>Wyss</u> – ones that came closest to prosecution were bank owned properties. This should not be a burden on 99% of the residents - would have worked with them on compliance, cleaning-up, etc – not to be unduly bearing – help them get through their issues.

<u>Fiebig</u> – how do we define acceptable – simple and definable – don't like grass; you can take it out – grass and weeds – all vegetation – in International Property Code. <u>Lobe</u> – Vagueness is present in the current ordinance. Have decided not to use these – asked for the Code. What's going to happen in future years – how is the Code going to be used in the future. <u>Lobe/Wyss</u> – we get a lot of calls – for everything – under tarps, etc.

<u>Reichelt</u> – if they receive a complaint about something – arsenal of things to leverage about something – how do you prosecute that? How do you advance the case?

Many cities around us – this is their Code – just in this area.

Consensus for Committee to go through International Code and see what may need to be in and struck Will be considered at the next Rules meeting.

Public Portion

Frank Cihula – major overkill, not resident-friendly – typically Mayor would appoint Building Commissioner – if a later date, he can fire Building Commissioner – can't remove them as property maintenance – back in 2003, Council did not want to adopt for residential – 2003-60. Vacant lots are vacant lots – they are vacant. Bob Kowalsky – heard words from someone who actually read it – hear about all the years – all the times – complaints that the office had – what was complained about – what is still wrong from the complaints – doesn't really work this way – should be residential – hammered all year long – only went to residential home on property – no I'm not – do you have a need for this? This man is telling you about the courts – how many times can't find anything going through the finance department – rental property – that one that was on my street – he needed railings – they put up plywood – palettes – this thing looked like a piece of junk – you forget the homeowner – need to figure out something in the WHISPER program – do see Alzheimer's – want to hack me up? Go right ahead. You don't have it together – hammer, hammer, iron fist is yours. Until you have a need, on paper in front of you. Mr. Ackerman – had one of those lots that he didn't cut. See property like Alaska – see a piece of paper before you do any of this stuff – no country, into a city – I have weeds in my lawn – I like the animals – don't think poison my lawn – when the gopher comes and goes along the groundhog – I don't plant food they like to eat. Someone that had a pink house – they didn't have the right paint job. Give us a whole bunch of laws – don't take it out of the garbage can. You need something to take care of those people.
