COMMITTEE MEETING FEBRUARY 17, 2010

Order of Business

1. Meeting was called because the seriousness of the situation and proposed tax issue demands more discussion and consideration

2. The Chairman, Finance Director and Mayor reviewed the situation. There was concern whether the 2.25% rate would pass and if we could get by with a lesser increase, even if we did not increase the credit for residents to provide a tax decrease for them.

3. Council requested a printed list of all expense cuts we have made, and suggested we review more areas that can be cut further. This information must be shared with the community because through excellent efforts, most cuts have not affected the level of service to residents and business. Cuts have been made. Most recent include no Cornfest and Sumer Camps in 2010.

4. Councilman David A. Reichelt stated that in comparison to many other safety forces he works with, we are and have been running very lean for many years and in his opinion hare already below acceptable standards. Mayor said that any further cuts in the Fire Department will mean we cannot participate in mutual aid – either giving or receiving. Even if we get mutual aid now it could be a 14-28 minute response time.

5. In 34 years since an income tax increase, the City has grown and demands on all City Services have greatly increased. This includes administrative requirements for all sewer projects. We also have the most highways and streams and hills per City area of any City around us.

6. Nancy Fellows made a motion to change our prior recommendation to Council and to place a 2.0% income tax on the ballot with a 1.5% credit. Councilman David Fiebig seconded. The vote passes 2 for, 1 against. However, in subsequent discussion with remaining Council Members attending, it was determined that this recommendation would not be carried with all of Council, and existing Ordinance would continue.

Public Portion commenced at 5:35 p.m. and concluded at 5:45 p.m. with comments made by:

Frank Cihula (who preferred a 2% rate and does not think Council should give up their right to change the credit in the future) and Robert Kowalski (who suggested limited term property tax levy that would place new revenue in identified areas of need for as long as we need it)
