#### **COMMITTEE MEETING MAY 27, 2010**

**Purpose of the Meeting was to discuss City Finances and any other business.**

**Meeting convened at 6:07 p.m.**

#### ***Order of Business***

- Discussed the Financial Reports for the Month of March and the Month of April 2010
- The City is continuing to reconcile on a monthly basis all the checking accounts, cash balances are balancing to zero every month; the City's Tax reconciliation is being done properly
- Questions were asked pertaining to some particular balances and were assured that all of the appropriations are being reported although there are some negative balances relative to some timing issues with revenues that are being received and everything is being expensed through the appropriate budgets

**It was the consensus of the Committee to accept the Financial Reports for the Month of March and the Month of April 2010**

- Committee spent time discussing five year projections for the budgets as prepared by Finance Director; shows that 2010 will be a breakeven year based on all of the expense cuts that have been made; definite deficits beginning 2011 right on through the 5 year period, this is without any staffing increases but there are some other improvements that we feel need to be made; there are some safety issues, Police Cars, etc.
- Operating Expenses continue to raise in spite of trying to hold the costs down on everything and we do need to find new streams of revenue; expecting a minimum of a 20% increase in the cost of Health Insurance
- Police Chief Collins was able to share some good information relative to his staffing and the fact that they are already at a limited number now based on number of nutrition; they similarly to the Fire Department at lowest levels; City has not purchased any cars all this year for the Car Replacement Program – minimum of eighteen months/twenty-four months before the City can get any new cars
- Mayor pointed out that it costs to maintain higher mileage cars
- Councilman Reichelt wanted to point out that on behalf of the Safety Committee the City is operating approximately at 2005 costs and that is in spite of some sufficient increases in some benefit packages – serious reduction in staffing – while it has not shown itself in reduction of City Services there is concern especially in the area of investigated work
- Councilman Reichelt, Chair of the Safety Committee, wanted the Finance Committee Minutes to reflect that it is the Safety Committee's observation that the current operating conditions for the Police and Fire Department are not sustainable in their present form. It is reaching a point where it is starting to risk us jeopardizing the safety of our public and our safety forces
- Chair Somich added that there was a recommendation from the Safety Committee and Councilman Biro to pursue a Tax Increase – this option would be further discussed in the Finance Committee.


