COMMITTEE MEETING OF OCTOBER 20, 2008

Purpose of the Meeting was to review Chapter 941 – Use of Public Property and any other business.

Meeting convened at 6:35 p.m.

- Introduction of draft of legislation to move responsibility of setting fees of the use of public property in the City from the Mayor to Council. This coincides with a request from the Ohio Auditor's Office. Also introduced the discussion of creating policies for generating income and promotion of the recreational facilities and Community Center. This "template" puts words on paper to begin discussion with the various stakeholders and moves toward a concurrent and final outcome to create a Master Plan for City Recreational Services. Lighting, concession stands, additional restroom, etc. Now with the ownership of Maplegrove Grange and the future of the Garfield property in question appropriate time to set wheels in motion. Moving the ball forward, been talked about for years. Emphasis on working together to create the best for the youth and residents of the Community.
- <u>Biro</u>: Good place to start is to analyze how the City currently operates the Community Center and the recreational activities.
- <u>Reichelt</u>: 2004 repealed the rules and created the Mayoral control. State Auditors request. He and others are unclear as to the exact relationship and workings of the WHBL. Would like to see all involved in a workshop like forum. Focus should be on the mechanics of how things are done and then set rates.

Public Portion opened at 6:52 p.m.

Cihula: There was a Master Plan created some years ago.

Fulton: Ouestions about WHBL, why not more adult activities, add bocce courts, add gymnasium

Grady: Should not be fees for using parks. Q. Any Federal funds used? A. Cannot deny access.

<u>Weger</u>: Perhaps this draft is to overbroad. Just set rates for the Community Center and codify those rates. Set a policy for who can use for free. Including Garfield is a little premature until there is a contract.

F. O'Ryan: Moving those groups out of City Hall: some were sponsored by Recreation long ago – allowed a 20% of fees collected to be paid as a "donation". Should consider not the 50% requirement but who is "sponsored" by Recreation. Please demand a Deposit be paid for Community Center reservation.

<u>Helton</u>: Amazed Reichelt does not know what the WHBL does. 52 years. Football, basketball. One fundraiser. Operates at a loss of 10K year. 17 guys who donate their time and expertise. <u>DR</u>: Asked if anyone else felt like he did, several including <u>Fellows</u> answered affirmative.

<u>Motuza</u>: Hurricanes (Girls Softball) pays the City league. Does not dictate field use. City League is through Willoughby. 135 girls.

M. O'Ryan: Have policy for fees by first of the year please.

<u>Cihula</u>: Garfield – demolition plan is to remove all except chain link in the rears along River Road.

Public portion closed at 7:34 p.m.

The wishes of the Committee were to move forward with another meeting; get more reports from other communities, get input from Leslie and WHBL; Council Office is compiling a study of sports association with local government and to determine fees for the Community Center.
