# CITY ENGINEER'S REPORT – Richard J. Iafelice, P.E., P.S.

• Just received a message from the Director of the Lake County Stormwater Management Department which may impact how the City may want to move forward on the projects where there are obligated funds for; the message from Tim Miller indicates that while the Commissioners are talking about a planned increase on County Sales Tax, the Board of County Commissioners is also looking to reduce the Stormwater User Fee by 50% in 2013. There is no explanation; however Tim Miller is indicating some reservation and concern about this reduction for

2013 and how it will impact the projects currently being planned for construction. The City has two projects planned for construction and have those funds obligated.

- City Engineer to follow up that the Rogers and Lamplight Lane Projects remain fundable
- City Engineer recommends the regular Service/Utilities Committee Meetings continue with Service initially, particularly given the message received from the LCSWM Director Tim Miller and to allow, more time for the Finance Director to review the Sewer Funds schedule a Utilities Committee Meeting maybe two weeks after Service. Will talk about projects, both Rogers Road and Lamplight Lane where the City has those funds and seeing if maybe the City wants to work more aggressively in lieu of the information just received this evening.
- City Engineer wanted to add additional compliments to the Mayor's message, regarding ODOT and the repairs being made to the I-90/91 Bridge; heretofore, we were not successful, but Council should know that the new Deputy Director of District 12 went out of his way, at the City's request, to take a look at the situation, and "piggybacked" it on to another project, that is how it is really getting funded.

Soccer Field discussion – plan is to grade the field this winter when the ground is frozen, hydro seed it in the spring at a cost of \$10,000 and mark off the parking lot with railroad ties and rope. Discussion followed with concerns about grading, leveling versus crowned for drainage.
