#### **COMMITTEE MEETING JANUARY 26, 2012**

Purpose of the Meeting was to discuss City Finances and any other business.

Meeting convened at 6:20pm

#### Order of Business

Mr. Brichacek: <u>Last year's Budget Results</u> – General Fund ended with over \$650,000 in surplus – results are encouraging since we had this in addition to purchasing two pieces of property. Just under income projection – took in 6.37 million dollars on a budget estimate of 6.38 million – very healthy. Obligated 6.2 million – all in all it was a good year – largest excess – state provided funding. Very conservative on that. Mayor's Court revenue was 200k below overall. Police activity pulled officers off the road, which accounts for the decline. January 2012 collections are ahead of January 2011 collections thus far.

Overall Summary – overall fund balance has increased by 300k. General Fund – budgeted 491k, ended the year with the 654k as outlined before. No questions from Council or Committee members.

<u>Debt Service</u> – two Notes that come due in 2012 – Communications Dispatch Center and 600k of Street Improvements. Second Note – 250k – refinancing of TIF Projects. Proposing memo to replace these Notes this year – combine them into single issue – most efficient and permissible. Most efficient way to do it – cost of issuing one Note. Successful and efficient – great interest rate – very efficient way to have the Note. We are regaining the confidence of the investment community. Retire 300k of the notes when going out for a new combined Note. Retiring 200k of that Note this year – funded by Road-Levy Fund. Communications – 50k of that Note. Safety Income Tax Levy Funds – 2012 we will have a full year worth of collections. 150k more than what we collected last year. On the TIF Note, reduce that by 50k this year. Temporarily advance funds from the TIF Fund – Note coming due in April – second half in. Return 50k, will carry over 14k, at that point, 50k in TIF Revenue – additional project.

Rates are still low – similar – under 1% the premium brings it down to 0.75%. If OK with this plan, reviewed with SSD Bond Counsel. Next month, legislation – reissuance of the Note.

Finance Committee encourages the legislation to be prepared for review at the second meeting in February. Is there a possibility we could go out for a longer Note? Notes typically done for a year, but can explore that with Counsel.

<u>Budget Timeline</u> – end of February – for Department Head Meeting; Consideration at the March 22<sup>nd</sup> meeting.

#### **Public Portion**

Frank Cihula – retiring some of the money on the communications center – using Safety Forces income tax – specific to the safety forces. Communications center for service department – overseeing of city property. Robert Kowalsky – glad you brought up that TIF – we will be sitting here in March – this is not the only city – taking the taxes from the school – and the other organizations and departments that receive taxes from us – million bucks in ten years. Changed the purposes – we can just think of something else to spend it on. You will take it for another five years or more.

#### Order of Business

Thank you to Councilman Germano for leaving work to attend the meeting. Apology given to Councilman Malecek for the early start of the meeting to make way for the W-E School Presentation.

<u>Rogers Road Update</u> - Survey and geotechnical completed. Rock is shallower than speculated. This may lead to a design change with decreased cost for the project. Construction wise - A wall will be built with concrete and steel piles drilled and encased with concrete and finished with pre-cast plain paneled walls: similar to noise barrier walls. Pavement up the hill could use repair at the same time if funds are in order. Rich will review the project with the Mayor.

<u>Lamplight Lane (Euclid Creek East Branch) Update</u> – this is a project examining the existing conditions along the Euclid Creek East Branch from Lamplight Lane to I-271 on to the north side of Rosewood Trail. The primary goal is to mitigate flooding on Lamplight Lane and to maintain a pristine environment of trees and enhance water quality. There are three houses primary affected by the flooding on Lamplight due to their construction near the original stream channel of the property before it was developed.

Recommendations for the project will include building a cut-off narrow trench, below the footer of these three homes, which will create an underground impervious wall. Also a 600' long by 4' high earthen levy dike will be created along the CEI property line to improve the channel flow of the water.

#### Public Portion

Linda Fulton – no questions specifically concerning the agenda, but would like to see the Service Committee discuss road maintenance as preventative rather than emergent. Bob Kowalski asked about the cost of the project and funding, in addition to seeing if Highland and/or Mayfield Heights would assist us.
