## CITY ENGINEER'S REPORT - Richard J. Iafelice, P.E., P.S.

- Referenced Status Report
- OPWC –Pre-applications are due tomorrow. City Engineer completed two applications one is to wrap up Maple Grove Road as we had discussed previously taking care of both the east and west side of the bridge after it is completed next year; reconstructing that road, the project cost is in the neighborhood of \$180,000-\$190,000. To maximize the City's point ranking and to try to get state assistance, we applied for 50% funding, 50% local share.
- The second project is a joint project to improve Worrell Road; major project, a \$600,000 project which Kirtland will share equally. It ranks very well as a joint project; \$600,000 project, local share for the City, probably about a \$100,000. Significant drainage problems, erosion problems.

<u>Potential Purchase of Fire Truck</u> – looking to replace the 1986 and 1989 trucks with one engine – bit of an albatross to sell – 1986 is already surplus – does not have a closed in cab and is yellow – not worth as much on the resale market. 1989 – prices are everywhere – talk to a broker. Springs replaced, front end brakes, tires on the engine, etc. Set of parameters for vendors – this is a demo model, which reduces the price – Pierce. Hold 1500 of hose – this truck meets all of the specs for what we are looking for – mission ready, it is a demo, needs repainting. May be on OK with vehicles for seven years after making this replacement – with the exception of air bottles.

Finance Director prepared a memo to address the debt financing that would have to be done for the purchase of the truck. He suggested that this needs to be done to provide the level of service necessary for the WHFD.

This would be a state-bid truck – under the state procurement program. Discussion ensued on particulars of the truck and the ability to purchase under debt financing. Should try to get space between Fire Department purchases and look at providing master vehicle purchasing plan for the entire City.

Have the time to purchase – truck comes from Illinois – 6 to 8 week process for delivery – will do the work here in Findlay.

Consensus for Recommendation from the Finance Committee to move forward with purchase with note financing set forward by the Finance Director.

## Order of Business

#### Fire Truck Purchase (Ordinances 30, 31, 32)

Memo authorizing the note issue – previously discussed in the Finance Committee. Appropriation ordinance – increasing by 450k so the Mayor can issue the Purchase Order. Note Ordinance is authorized. Authorizing issuance of the note – almost identical to the ordinance prior. Bond anticipation note. Maximum interest rate of 4% - anticipated rate around 1%. Will also authorize bond counsel – cannot be passed as an emergency, but needs to be passed tonight to get things moving on it. Less than a one year note so we can combine notes together for one at a low rate – just one issuance costs.

Numeric Change on Ordinance 2012-32 should be not to exceed \$450,000 - secure the purchase, finance and equip in Section 1.

"Whereas" clause should read "establishes the estimated total cost of purchasing, financing and equipping the truck to be approximately \$450,000; and"

Section 1 of the Ordinance should read: "...secure the purchase, financing, and equip a new fire truck from Pierce Manufacturing, Inc. of 2600 American Drive, Appleton, WI 54912 at a total cost not to exceed \$450.000."

Recommend to adopt Ordinances 30, 31, and 32 at tonight's Council Meeting (32 as amended).

#### Tax Budget of the City of Willoughby Hills

Required Step – in order to levy property taxes – need to exhibit to the County – Council must adopt by July 15<sup>th</sup> and file with the County by July 20<sup>th</sup>. No changes in rate for this year.

Recommend leaving Ordinance on First Reading and Adopt upon Third Reading projected on July 12<sup>th</sup>. Financial Status and Health of the City

Generally no red flags – income tax collections are consistent and on budget. On General Fund estimate, a bit behind – ahead on Safety Forces. Encouraging notes are the Court – significantly ahead of last year, will exceed estimated amount at current pace. Employee health care should also come in below amount budgeted.
