## **ORDINANCE NO. 2008 – 14**

---

**AN ORDINANCE AMENDING PART NINE – STREETS, UTILITIES, AND PUBLIC SERVICES CODE, TITLE FIVE – OTHER PUBLIC SERVICES, CHAPTER 941 USE OF PUBLIC PROPERTY, SECTION 941.07 – WILLOUGHBY HILLS COMMUNITY CENTER BY NAMING ROOMS IN HONOR OF MAYOR MORTON E. O’RYAN AND MAYOR MELVIN G. SCHAEFER.**

**WHEREAS**, Ordinance No. 1998-48 was adopted on July 23, 1998, deeming it appropriate and fitting that the proposed facility be designated as the “Willoughby Hills Community Center” and constructed on the Roemisch Field site opposite City Hall; and

**WHEREAS**, the building was funded, in part, by the hard work of citizens who shared the vision of what eventually became the aforementioned community center; and

**WHEREAS**, over the course of several decades, two city leaders spearheaded private fundraising efforts that contributed to the construction of the building; and

**WHEREAS**, these two City leaders selflessly expended thousands of hours of personal time in pursuit of a dream that was realized with the construction of this building; and

**WHEREAS**, two rooms located in the lower level of the building bear the name of civic organizations that were also instrumental in the accumulation of donated funds that were used to construct the building; and

**WHEREAS**, the Council of the City of Willoughby Hills deems it prudent to recognize the contributions of these two City leaders and their visionary efforts to build the Willoughby Hills Community Center by naming rooms in their honor.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO, THAT:**

**SECTION 1.** Section 941.07 of the Codified Ordinances of the City of Willoughby Hills be, and hereby is amended to read and provide in its entirety as follows:

“The building constructed on the Roemisch Field site opposite City Hall is hereby formally named “The Willoughby Hills Community Center.”

The room currently known as the “Community Room” shall hereafter be formally named the “O’Ryan Room” in recognition of the tireless work and contributions of Mayor Morton E. O’Ryan, and his wife, Florine.

The room currently known as the “Orchard Room” shall hereafter be formally named the “Schaefer Room” in recognition of the tireless work and contributions of Mayor Melvin G. Schaefer and his wife, Jeanette.

- (a) The schedule of charges for the use of the meeting facilities and room rentals in the Willoughby Hills Community Center shall be established by the Mayor of the City of Willoughby Hills.
- (b) The use and rental of the Willoughby Hills Community Center and any of the rooms therein, shall be subject to the rules, regulations and policy procedures adopted by the Mayor of the City of Willoughby Hills.
- (c) The Director of Finance shall be directed to deposit all income derived from the renting of rooms in the Willoughby Hills community Center into the General Fund to defray the operational costs of the Willoughby Hills Community Center.”

**SECTION 2.** The Mayor is hereby authorized and directed to install new interior signage identifying the rooms as designated above.

**SECTION 3.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 4.** This Ordinance shall be in full force and effect at the earliest time permitted by law.
