## ORDINANCE NO. 2008-4

**AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF WILLOUGHBY HILLS TO ENTER INTO A LEASE AGREEMENT WITH WESTERN RESERVE HARLEY-DAVIDSON FOR THE PURCHASE OF THREE HARLEY-DAVIDSON MOTORCYCLES AND DECLARING AN EMERGENCY.**

WHEREAS, the Council of the City of Willoughby Hills adopted Ordinance No. 2005-109 on October 13, 2005 for the leasing of (3) Harley-Davidson Motorcycles; and

WHEREAS, said lease is due to expire in March of 2008.

**NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:**

**SECTION 1.** The Mayor is hereby authorized and directed to enter into a Lease Agreement with Western Reserve Harley-Davidson, located at 8567 Tyler Boulevard, Mentor, Ohio 44060 substantially pursuant to the terms and conditions as identified in said Agreement, for the leasing of three (3) 2008 Harley-Davidson Motorcycles, FLHP with factory anti-lock brake systems in "Houston Style" paint, for a period of thirty-six months at a monthly payment of \$158.03 per motorcycle.

**SECTION 2.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 3.** This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual daily operation of the Police Department; to wit: immediately provide the Willoughby Hills Police Department with three (3) 2008 Harley-Davidson Motorcycles per the terms and conditions as outlined in the Lease Agreement with payment beginning March of 2008; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.




