ORDINANCE NO. 2008-52

AN ORDINANCE AMENDING PART ONE – ADMINISTRATIVE CODE, TITLE FIVE – ADMINISTRATIVE, CHAPTER 135 – DEPARTMENT OF FINANCE OF THE CODIFIED ORDINANCES OF THE CITY OF WILLOUGHBY HILLS BY THE ADDITION OF SECTION 135.30 – ACCEPTANCE OF GIFTS.

WHEREAS, the City Council of Willoughby Hills has deemed it necessary to amend Chapter 135 – Department of Finance of the Codified Ordinances of the City of Willoughby Hills by the addition of *Section 135.30 – Acceptance of Gifts*.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE COUNTY, STATE OF OHIO THAT:

SECTION 1. Part One – Administrative Code, Title Five – Administrative, Chapter 135 – Department of Finance of the Codified Ordinances of the City of Willoughby Hills be and it is hereby amended by the addition of **Section 135.30 – Acceptance of Gifts** which shall read and provide in its entirety as follows:

“135.30 ACCEPTANCE OF GIFTS.

(a) The Director of Finance is hereby authorized to accept gifts donated to the City other than real estate, to be used for municipal purposes, the estimated value of which does not exceed ten thousand dollars (\$10,000). Gifts to the City exceeding ten thousand dollars (\$10,000) in estimated value may be accepted by the Director of Finance upon the approval of Council.

(b) The Director of Finance is hereby authorized and directed to establish and maintain such separate accounts as may be necessary for the acceptance and use of gifts to the City.

(c) The Director must report in writing to Council any and all gifts over \$500.00 within thirty (30) days of receipt.

(d) Nothing herein shall require the Director of Finance to accept any gift, of whatever kind or value, offered to the City.

SECTION 2. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This Ordinance shall be in full force and take effect at the earliest time permitted by law.
