## ORDINANCE NO. 2008 – 82

### AN ORDINANCE ACCEPTING THE BID OF HUMMEL CONSTRUCTION CO. OF RAVENNA, OHIO FOR CONTRACT A – GENERAL IMPROVEMENTS FOR THE DISPATCH IT IMPROVEMENTS PROJECT AND DECLARING AN EMERGENCY.

**WHEREAS**, the Council of the City of Willoughby Hills on August 21, 2008, by motion, granted the Mayor authorization to advertise for bids for the City's for the Information Technology and Dispatch Project; and

**WHEREAS**, the Council of the City of Willoughby Hills on October 23, 2008 by motion, granted the Mayor authorization to re-bid the Information Technology and Dispatch Project at City Hall and once again advertise for bids as the bids received on September 26, 2008 were excessive; and

**WHEREAS**, the Council of the City of Willoughby Hills has reviewed and accepts the recommendation as provided by the Architectural Manager William G. Gallagher in his letter of November 7, 2008, attached hereto as Exhibit A, consisting of (2) pages and incorporated herein by reference, finding the bid of **\$86,800.00** for **Contract A – General Improvements** as received by **Hummel Construction Co.** to be the lowest bid to be in conformance with all contract requirements.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:**


**SECTION 1.** The Mayor is hereby authorized and directed to accept the bid of **\$86,800.00** for **Contract A – General Improvements** as submitted by **Hummel Construction Co. of Ravenna, Ohio**, substantially pursuant to the terms and conditions as identified in said bid.

**SECTION 2.** The Director of Finance is authorized and directed to return all bid bonds to the unsuccessful bidders.

**SECTION 3.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 4.** This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual daily operation of a municipal department, and further reason being to allow the City to accept the bid and enter into a contract within 30 days as specified in the bid proposal of **Hummel Construction Co.**; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.




